JUDGMENT Employment Tribunals Rules of Procedure 2013 Rule 21

No Response has been presented within the requisite time limit, and on the basis of the available information before the Employment Judge:

The judgment of the tribunal is:

- 1. The claimant was unfairly dismissed;
- 2. The claim for breach of contract in respect of notice pay is upheld and I award the claimant damages in a sum to be determined by the tribunal
- 3 By 4pm on **9 June 2017**, the claimant shall set out in writing, to the tribunal and to the respondent, full details of the remedy she is seeking; including a calculation of compensation claimed.
- 4 If the respondent wishes to make any submissions on the question of remedy, these shall be set out in writing to the tribunal and to the claimant by 4pm on **23 June 2017**.
- 5 The hearing listed for 29/30 June 2017 at Stoke on Trent is cancelled.
- 6 Upon compliance with Paragraphs 3 & 4 above then an Employment Judge will consider the question of remedy.
