# JUDGMENT

It is the unanimous judgment of the Tribunal that:

- 1. The Claimant was unfairly dismissed.
- 2. The Respondent subjected the Claimant to discrimination arising from disability contrary to section 15 Equality Act 2010 in the manner of his dismissal.
- 3. The Respondent shall pay £40,238.41 to the Claimant as set out in the schedule to this judgment.
- 4. The recoupment provisions apply as follows:

Prescribed period: Total award:	10 June 2015 to 3 May 2017 £39,922.32 (excluding grossing up)
Prescribed element: Balance	£23,383.90 £16,538.41

5. The Respondent shall pay a financial penalty of £5,000 to the Secretary of State

pursuant to section 12A Employment Tribunals Act 1996.
