The Judgment of the Tribunal is that the Hearing set down for 10 July 2017 and the subsequent 4 days is postponed. - 2. Mr Hay for the claimant indicated that he had difficulty in proceeding due to very unfortunate personal circumstances. Further, he explained that there had been an accident over the weekend immediately preceding 10 July 2017 which had resulted in the death of an employee of the respondents whilst carrying out works on a road in East Kilbride. The circumstances of that accident might be of relevance to the case brought by the claimant. It was recognised that there would likely to be a fatal accident enquiry and that it might be inappropriate for evidence to be given on the various matters in this case given that circumstance. In addition one of the witnesses who was to appear in this case for the claimant, Mr Burnside, had been present at the incident which had resulted in the death of his colleague. For these reasons Mr Hay sought a postponement of the Hearing set to commence on 10 July 2017.
- 15 3. Mr Stewart for the respondents said that he understood the reasons advanced for postponement. He did not oppose postponement on the basis of the personal circumstances involving a member of Mr Hay's family. He was unclear as to whether the incident over the weekend, about which he said he knew little, would impact upon this case.

4. The Tribunal adjourned. It returned shortly after adjourning. It was confirmed to parties that the postponement application was granted. Discussion took place at to proceedings in the case. At the conclusion of the discussion, the agreed course was that parties would be given 28 days from date of the PH in which to consider their position as to the Hearing being set down for fresh dates or whether it was appropriate to sist the case pending any fatal accident enquiry in relation to the very unfortunate accident at the weekend.
