The unanimous judgment of the tribunal is as follows:

JUDGMENT

1. The tribunal has no jurisdiction to consider this appeal. The claim form was presented to the tribunal 8 hours after the expiry of the statutory time limit. It was reasonably practicable to present the claim before the end of the time limit and the tribunal therefore has no power to grant an extension of time.
2. Had the tribunal jurisdiction to consider the appeal, it would have affirmed both the prohibition notices served on 12 May 2017.
