- 1. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £678.93, representing 2 years' service both when aged over 41 years at her weekly pay of £226.31.
- 2. The claimant was dismissed in breach of contract in respect of notice and the respondent is ordered to pay damages to the claimant in the net sum of £431.86.
- 3. The respondent has failed to pay the claimant's holiday entitlement and is ordered to pay the claimant the gross sum of £311.17.
- 4. The respondent has made an unauthorised deduction from the claimant's wages and is ordered to pay the claimant the gross sum of £1,131.55.

Mrs V Boyd

- 5. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £8,090.82, representing 18 years' service when aged over 41 years at her weekly pay of £299.66.
- 6. The claimant was dismissed in breach of contract in respect of notice and the respondent is ordered to pay damages to the claimant in the net sum of £2,860.94 (12 weeks' net pay at her weekly net pay of £268.87 after credit for £365.50 JSA received).
- 7. The respondent has failed to pay the claimant's holiday entitlement and is ordered to pay the claimant the gross sum of £695.21.

8. The respondent has made an unauthorised deduction from the claimant's wages and is ordered to pay the claimant the gross sum of £1,498.30.

9. The hearing listed on 9 January 2019 is cancelled.
