It was ordered by the Tribunal that the claims of the Claimants whose names and case numbers appear in the Annexe to this Judgment should be heard together.

By an order made on 19 December 2018 (wrongly dated 19 December 2019) and sent to the parties on 10 January 2019 the First Respondent, Meta VS Ltd, was ordered as follows:

- 1. To notify the Claimants and the Third Respondent on or before 25 January 2019 whether it disputed that there was a relevant transfer of the business within the meaning of TUPE from Meta Vision Systems Ltd [the Second Respondent] to Meta VS Limited in or about early August 2017; and
- 2. In the event that it disputed that there was a relevant transfer, to provide to the same parties the further particulars set out in detail in the order, on or before 30 January 2019.
- 3. It was further ordered that if such information was not provided to the Claimants, the Third Respondent and the Tribunal on or before 30 January 2019, a judgment on liability in the Claimants' favour would be entered against Meta VS Limited in the case of each Claimant.

By a letter dated 25 January 2019, Meta VS Ltd informed the Tribunal that it did not believe that there was a relevant transfer of the business within the meaning of TUPE from Meta Vision Systems Limited to Meta VS Ltd.

Meta VS Ltd then failed to comply with the order for the provision of further particulars and judgment on liability is now entered.

JUDGMENT - LIABILITY

Case Number: 3329312/2017 & Others

(1) The Claimants' claims for unfair dismissal, payment in lieu of annual leave, unlawful deductions, breach of contract and a failure to consult pursuant to regulation 13 of the Transfer of Undertakings (Protection of Employment) Regulations 2006 are upheld against the First Respondent, Meta VS Ltd.

(2) The hearing listed before the Employment Tribunals Watford on 2, 3 and 4 September 2019 will now proceed as a hearing of issues relevant to remedy only.
