# **JUDGMENT**

- 1. The claimant was an employee within the meaning of section 230 (1) Employment Rights Act 1996.
- 2. There was a transfer of an undertaking between the first and second respondent pursuant to the Transfer of Employment (Protection of Employment) Regulations 2006 ('TUPE') on or about 30 August 2018.
- 3. Pursuant to Regulation 4 TUPE the claimant's contract of employment transferred to the second respondent.
- 4. The transfer was the sole or principal reason for the claimant's dismissal and this was an unfair dismissal by virtue of Regulation 7 TUPE.
- 5. There was a failure to inform and consult pursuant to Regulation 13 TUPE.
- 6. The claimant was entitled to but not paid for annual leave pursuant to the Working Time Regulations 1998 throughout the entirety of his employment
- 7. The claimant was never provided with a statement of particulars of employment pursuant to section 1 of the Employment Rights Act 1996 and is entitled to an award under s38 Employment Act 2002.
