JUDGMENT

The judgment of the tribunal is as follows:-

Wages

1. The complaint of unauthorised deduction from wages succeeds. The respondent made an unauthorised deduction from the claimant's wages in the period 1 November 2022 to 31 January 2023.
2. The respondent shall pay the claimant the gross sum of £17,499.99.

Breach of contract

3. The complaint of breach of contract in relation to pension contributions succeeds.
4. The respondent shall pay the claimant the gross sum of £293.52 in relation to pension contributions.

Employer's contract claim

5. The respondent's contract claim fails and is dismissed. The claimant has agreed to return the property and the parties will make arrangements for this.
