That the CCEA:

- will identify dates on which QPP files relating to GCE Mathematics (M2) (summer 2011) could have been destroyed in accordance with the CCEA Disposal of Documents Schedule; and
- will contact all contractors and request evidence of destruction of CCEA confidential material from 16 September 2011 to 29 February 2012 (inclusive);

and will provide to the appellant no later than the 19th December 2014, the dates identified and copies of the requests to contractors. CCEA will provide to the appellant any evidence received from the contractors no later than 12 January 2015.
