- a) The Ministry of Justice, the second respondent, is to provide the information requested in Mr. Johnson's questions of June 25 2014 as amended in the schedule to this order within 20 working days of the date of this order;
- b) The information provided to Mr. Johnson in answer to the FOI question in the schedule to this order will be provided by the second respondent from the LIBRA and IFAS systems;
- c) The appellant accepts that there has been no analysis of the underlying court records, which the Ministry of Justice considers to be the complete source of data to answer the appellant's questions of June 25 2014;
- d) This consent order in relation to records held by Barkingside Magistrates' Court for Council Tax liability orders sought by the London Borough of Redbridge is of no precedential value that the costs limit provided for in section 12 of the Freedom of Information Act 2000 is not engaged in any other request made in relation to any other Magistrates' Court and without prejudice as to whether the information requested by the

appellant might be exempt from disclosure under section 32 of the Freedom of Information Act 2000:

IT IS ORDERED THAT:

- 1. The appeal be withdrawn by consent;
- 2. In accordance with the Tribunal's normal practice, there be no order for costs
