

Freedom of Information Act 2000 Environmental Information Regulations 2004 Decision notice

Decision (including any steps ordered)

- 1. The complainant has requested information about Grenfell Tower including fire risk assessments, copies of invoices, correspondence with a contractor, details of certain council employees and copies of oversight policies.
- 2. The Commissioner's decision is that the Royal Borough of Kensington & Chelsea ("the Royal Borough") has failed to issue a substantive response within 20 working days and therefore breached Section 10 of the Freedom of Information Act ("the Act") and, or to the extent that the requested information is environmental, Regulation 5(2) of the Environmental Information Regulations ("the Regulations").
- 3. The Commissioner requires the public authority to take the following steps to ensure compliance with the legislation:
 - Respond to the request, by providing a substantive response in accordance with the Act and, or to the extent that the requested information is environmental, provide a substantive response in accordance with the Regulations.
- 4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



Request and response

5. On 13 August 2017, the complainant contacted the Royal Borough via the whatdotheyknow.com website and requested information in the following terms:

"Please provide the following documents:

- 1) Details of item FP/14/03563 in Building Control records
- 2) Details of when a full plans decision notice is required according to Building Regulations, and when a completion certificate is required, and who signs them off respectively
- 3) All correspondence with Rydon about Grenfell Tower refurbishment both prior to and after the company was awarded the contract
- 4) All invoices regarding Grenfell Tower refurbishment
- 5) All correspondence regarding Grenfell Tower between RBKC and KCTMO, or RBKC and Rydon, that mentions "demolition"
- 6) Professional qualifications and salary of the person who was Council's Building control officer on 15 May 2015, how long they have been in their role and whether it is the only position they hold in the Council and outside it."
- 6. On 11 September, the complainant submitted a further request to the Royal Borough via whatdotheyknow.com in the following terms:
 - "1) Please provide the following relating to Council dwellings owned by the Royal Borough of Kensington and Chelsea and managed by the KCTMO:
 - (i) All fire risk assessment reports carried out on all of the KCTMO managed dwellings from 2014 to date and all enforcement or improvement notices served
 - (ii) The protocol for the process on oversight for subcontracting of building or refurbishment works in KCTMO properties
 - (iii) The protocol for the process of oversight between KCTMO and RBKC on financial, legal and safety matters
 - "2) Please confirm whether
 - (i) RBKC employes a member of the Institute of Clerk of Works or an inspector of similar standing and assigned them to each construction and refurbishment work site [sic]
 - (ii) If employed please confirm the level of qualification, salary



associated with this role and how much time was allocated per project/site."

7. The Royal Borough acknowledged the first request on 14 August 2017 and the second on 12 September 2017.

Scope of the case

- 8. The complainant contacted the Commissioner on 12 December 2017 to complain that she had not received a response from the Royal Borough.
- 9. On 15 January 2018, the Commissioner wrote to the Royal Borough to notify it of the complaint. In line with normal practice, she requested that the Royal Borough issue a response to the complainant within 10 working days.
- 10. The Royal Borough did not respond to the letter of 15 January 2018 and, on the evidence available to the Commissioner at the time of issuing this notice, has not issued any further response to the complainant.
- 11. The complainant contacted the Commissioner on 5 February 2018 to request a Decision Notice considering the Royal Borough's compliance with the Act and, to the extent that the requested information is environmental, the Regulations.
- 12. The Commissioner considers that the scope of this investigation is to determine whether the Royal Borough has complied with Section 10 of the Act and, to the extent that the requested information is environmental, Regulation 5(2) of the Regulations.

Reasons for decision

13. Section 1(1) of the Act states that:

Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him.
- 14. Section 8(1) of the Act states:



In this Act any reference to a "request for information" is a reference to such a request which -

- (a) is in writing,
- (b) states the name of the applicant and an address for correspondence, and
- (c) describes the information requested.
- 15. The Commissioner considers that the request in question fulfilled these criteria, and therefore constituted a valid request for recorded information under the Act.
- 16. Section 10 of the Act states that response to requests made under the Act must be provided "promptly and in any event not later than the twentieth working day following the date of receipt."
- 17. Regulation 5(1) of the Regulations states that

"a public authority that holds environmental information shall make it available on request."

18. Regulation 5(2) of the Regulations states that

"Information shall be made available.....as soon as possible and no later than 20 working days after the date of receipt of the request."

- 19. From the evidence provided to the Commissioner in this case, it is clear that the Royal Borough did not respond to the request within 20 working days and has therefore breached Section 10 of the Act.
- 20. From the evidence provided to the Commissioner in this case, it is clear that, to the extent that the requested information is environmental, the Royal Borough has breached Regulation 5(2) of the Regulations.



Other matters

- 21. The Commissioner is conscious that the public authority has been dealing with a tragic and major incident within the Borough, which has attracted national attention and which is now subject to a high profile public inquiry. The Commissioner recognises that these are exceptional and difficult circumstances. Nevertheless, the public authority's statutory obligations remain and whilst the Commissioner is a proportionate and reasonable regulator, she is unable to ignore a complete lack of response to an information request. Likewise, she cannot ignore a complete lack of engagement with her office when undertaking her regulatory functions.
- 22. The Commissioner's preference is always to resolve complaints on an informal basis where possible. Unfortunately, in this case, the Royal Borough's complete failure to engage with her office in any way has rendered that approach impossible.
- 23. Accordingly, this is one of a series of Decision Notices which will be issued to the Royal Borough in relation to these issues within a short space of time. All of these Decision Notices have arisen from complaints made to the Commissioner about the timeliness of responses to requests made, to the Royal Borough, under the Act and/or the Regulations. The Commissioner's position is that the Royal Borough's failure to engage with her Office has left her with no alternative but to issue a Decision Notice in each case.
- 24. The Commissioner would strongly encourage the Royal Borough to engage properly with her Office in future.



Right of appeal

25. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
