

Freedom of Information Act 2000 (FOIA)

Decision (including any steps ordered)

- 1. The complainant requested information relating to the television production Strictly Come Dancing. The BBC has failed to respond to this request.
- 2. The Commissioner considers that the BBC breached section 10(1) FOIA in the handling of this request.
- 3. The Commissioner requires the public authority to take the following steps to ensure compliance with the legislation.
 - The BBC must provide the complainant with a response to this request in accordance with its obligations under FOIA.
- 4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

Request and response

5. On 23 December 2017 the complainant wrote to the BBC and requested information in the following terms:



"Under the Freedom of Information Act you are requested to provide the voting figures for each of the final four strictly come dancing candidates 2017."

6. The BBC has failed to respond to this request.

Scope of the case

- 7. The complainant contacted the Commissioner on 27 February 2018 to complain about the way the request for information had been handled.
- 8. The Commissioner has considered whether the BBC has dealt with this request in accordance with its obligations under section 10(1) FOIA.

Reasons for decision

9. Section 10(1) provides that:

"Subject to subsections (2) and (3), a public authority must comply with section 1(1) promptly and in any event not later than the twentieth working day following the date of receipt."

10. Section 1(1) provides that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and(b) if that is the case, to have that information communicated to him."

11. The request was made on 23 December 2017 and a response has not yet been provided. The Commissioner therefore finds that the BBC breached section 10(1) in failing to respond within 20 working days.



Right of appeal

12. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from: First-tier Tribunal (Information Rights)
