

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 2 February 2021

Public Authority: St Mary's University, Twickenham

Address: Waldegrave Road

Strawberry Hill Twickenham TW1 4SX

Decision (including any steps ordered)

- 1. The complainant requested information from St Mary's University, Twickenham ("the University") about student meal numbers from the canteen facilities and other related information. By the date of this notice the University had failed to provide a substantive response to this request.
- 2. The Commissioner's decision is that the University has breached section 10(1) of the FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the University to take the following steps to ensure compliance with the legislation.
 - Respond to the complainant's request in accordance with the FOIA.
- 4. The University must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.



Request and response

5. On 3 November 2020, the complainant wrote to the University and requested information in the following terms:

"Can you please tell me how many students had an evening meal from the canteen facilities on the 13th February 2020, the 27th February 2020, the 13 March 2020, the 23rd March 2020, the 26th March 2020 and the 6th April 2020? (these figures are recorded via the students meal points system)."

6. To date, a substantive response has not been issued.

Scope of the case

- 7. The complainant contacted the Commissioner on 3 December 2020 to complain about the failure by the University to respond to her request.
- 8. The Commissioner has considered whether the University has complied with its obligations in relation to the time for compliance at section 10(1) of the FOIA.

Reasons for decision

9. Section 1(1) of the FOIA states that:

Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him.
- 10. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt."
- 11. On 4 January 2021, the Commissioner wrote to the University, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days.
- 12. Despite this intervention the University has failed to respond to the complainant.



13. From the evidence provided to the Commissioner in this case, it is clear that the University did not deal with the request for information in accordance with the FOIA. The Commissioner finds that University has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the FOIA.



Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
