## Before His Honour Mr. Justice WILLIAMS.

#### Melbourne, Tuesday, 8th March 1949, at 12.15 p.m.

#### Mr. J. B. TAIT K.C., with him • Mr. L. VOUMARD (instructed by Messrs. Corr & Corr) appeared for the Plaintiff.

Mr. T. W. SMITH K.C., with him Mr. H. A. WINNEKE (instructed by 10 the Commonwealth Crown Solicitor) appeared for the Defendant.

Mr. TAIT: In this matter, if your Honour pleases, the Plaintiff is the executor and trustee of the will of F. C. H. Thomas deceased and the matter arose under the Federal Estate Duty Assessment Act, the deceased having died on 28th February 1944. At the time of his death, he was a partner in the firm of Maples, and he had at the time of his death four or possibly five other partners.

HIS HONOUR: According to the affidavit with the papers, he died on 28th January, though it does not matter.

Mr. TAIT: I am told that my copy is wrong and that it should be 20 January. The partnership, which had been carried on for many years, was conducted under and pursuant to a written partnership deed which contained a clause and various provisions as to what should happen upon, *inter alia*, the death of any of the partners.

The particular matter which has importance in this case is that, under those provisions of the deed, on the death of a partner there were certain options given to other partners. One set of options was to two partners— Louisa Jones and Lorna Hannan—if they were living, and there was another option to the other surviving partners. Between them, those options entitled those persons to purchase from the deceased's estate his interest 30 in the partnership capital. Then upon the exercise of those options, the purchase price should be calculated without adding or taking into account any sum for goodwill.

HIS HONOR : What clause is that ?

Mr. TAIT: Clause 12, proviso. That says-

"It is specifically agreed and declared that in computing "the amount of purchase money payable on the exercise of "any option, . . . taken into account for goodwill."

HIS HONOR: This is the only item left in dispute now, is it not?

Mr. TAIT: Yes. The original assessment was objected to on various In the High grounds.

HIS HONOR: There were three companies, apparently.

Mr. TAIT: Yes, the valuation of shares in three companies and some other items, and to that extent the objection was given effect to in an Transcript amended assessment, because in that amended assessment the values of of Shortthose shares were adopted as contended for.

There was one matter still left outstanding, which was the subject of Proof a further amended assessment, and we are concerned with that. Those continued, 10 particular shares were the subject of a charge which was an asset in this estate. The charge was  $\pounds 40,000$  and it was more than the value of the shares over which the charge lay. Accordingly, the value of that asset could not be more than the value of the shares.

When those shares were reduced in value for the purpose of valuing to the extent that the shares were owned by the deceased, no alteration was made in the value assigned to the charge. That was adjusted in the further amended assessment. That being cleared up, it left one matter in dispute between the parties, the matter now before the Court. That is the question of goodwill, namely, that in valuing that asset of the deceased 20 which consisted of his interest in the partnership, account should be taken

of the value of the goodwill.

The parties have gone further. They have agreed upon what that value would be if it should be included, and the figure is £20,000. matter was the subject of a decision in this Court in Milne's case comparatively recently. Milne's case is the Trustees Executors and Agency Co. Ltd. v. The Commissioner of Taxation, reported in 69 C.L.R., page 270.

HIS HONOR: Who were the partners in Maples ?

Mr. TAIT: The deceased, Robert Nathan, Louisa Jones and Lorna Hannan (daughters of another Nathan and nieces of Robert Nathan) 30 and three others---Lionel Newton, Laurie Joseph Newton and Donald Lamond.

HIS HONOR: I take it that these options to purchase shares of the deceased were given to some of the surviving partners?

Mr. TAIT: There were two sets of options, one being to the two women -Louisa Jones and Lorna Hannan. That was an option to take  $6\frac{1}{4}$ % of Thomas's interest in the capital. Then he gave an option as to all the rest of his interest--the difference between 100% and  $6\frac{1}{4}\%$ --to all the other partners; that is, of course, other than himself and the two women, also excluding Lamond. Actually, he gave that option to Robert 40 Nathan and the two Newtons. I am told that the Newtons were in the

Nathan family somewhere.

In Milne's case, of which Your Honor will no doubt have a recollection--

HIS HONOR: Yes; I read it before I came into Court.

Mr. TAIT: Your Honor will see that the position which arose was the very thing here. There was a partnership agreement with a provision that, on the death, there might be a taking over, and that no allowance

In the High should be made in respect of the goodwill of the business. That was exercised by the survivors, no allowance being made for goodwill, but the question came up under the Estate Duty Act on the death of that partner, and it was held by the Full High Court, with three Judges forming a majority -Rich J., Starke J. and Your Honor, with Chief Justice Sir John Latham and McTiernan J. dissenting—that within the meaning of Section 8 (4) (e)of the Estate Duty Assessment Act the deceased partner at the time of his

death had a beneficial interest in the goodwill-(reads decision).

That was the decision and I am not proposing to attempt to distinguish my case here on the facts. I recognise that Your Honor will feel that it 10 is a binding authority and that you should follow it, and I cannot expect Your Honor to do anything else. Accordingly, I do not propose before Your Honor to re-argue that case and to argue that the decision of the majority was wrong. I desire to make the formal submission that the decision of the majority was wrong, leaving it open to me, not confining myself to any particular grounds, to adopt the views of the Justices who were in the minority.

In this case, we desire to carry the matter further. As information to Your Honor, I may state that it has not been decided at the moment whether we will go by appeal from Your Honor's decision following this 20 case to the Full High Court, or attempt to carry the matter direct to the Privy Council, but my instructions are that the executors here do propose to follow one course or the other.

HIS HONOR: I should think it would be the best course to go to the Privy Council. I do not know whether I am advising the executors.

Mr. TAIT: I may add that I have only come into the matter quite recently.

HIS HONOR: You now have two Judges whose views are not known, but it seems rather unlikely that the Full Court would reverse a recent decision.

Mr. TAIT : It may well be, but I think that is a matter for the executors after further advice. I am simply informing Your Honour that we have in mind going on somewhere, as we have to do to get anywhere with this matter.

HIS HONOR: At any rate, you want to prove your case?

Your Honor, this matter comes up by way of objection treated as an appeal and referred to the Court. There are certain papers sent on by the Commissioner to the Court. I think the practice is to put in the return 20 for assessment and the assessments as exhibits. I am not sure whether

HIS HONOR: I have always regarded those as sort of quasi pleadings. It can go on the notes that the documents filed in Court in connection with the appeal are treated as being before the Court on the appeal.

Mr. TAIT: Very well. May I just note them for the purpose of the notes to identify things that are there by occasion as in evidence. There is a notice dated 28th September, 1948, signed by the Crown Solicitor and addressed to us. It is headed, "Notice of transmission of objection."

HIS HONOR: The first document here is the ordinary document 30 signed on behalf of the Commissioner of Taxation, dated 28th September, 1948, forwarding to the Court the taxpayer's objection and also the following documents :---

I arranged to have here available a letter that is not mentioned in the documents to which Your Honor has referred. It is dated 17th February 1948 and addressed to the Commissioner, but it deals only with the position as between the first amended assessment and the second, pointing out that the first one was in error in the matter I have mentioned to Your Honor of the valuation of the charge. I have a good deal of doubt whether I ought to put that in.

HIS HONOR: Have you a further amended assessment?

Mr. TAIT: Yes. The further amended assessment is one of the documents Your Honour quoted as being before the Court. It would 10 only be explanatory.

HIS HONOR: Attached to that there is an alteration sheet which shows that there was deducted the reduced value of shares in Block Pty. Ltd.,  $\pounds 16,939$  and Melbourne Properties Ltd.,  $\pounds 4,650$  charged in favour of the deceased.

Mr. TAIT: With the explanatory paper, I think it is sufficient.

HIS HONOR: The amended value of the estate is £204,984.

Mr. TAIT: Yes. I think the letter of which I am speaking would not carry the matter further.

HIS HONOR: This seems to be reducing the charge.

Mr. TAIT: Yes, the value of the charge; accordingly the value is reduced.

HIS HONOR: Has the supplemental deed anything to do with this point?

Mr. TAIT: I do not think it has. The provisions in the original deed dealing with this point run through it very largely and give us some reference to this same matter in several places. The original deed is not confined to the one sentence I read. Accordingly, any alterations made to the deed conceivably might have some bearing on construction. I personally do not think they have, but I thought it best to put it in. 30

HIS HONOR: If you are going to appeal in this matter, especially if you are going to the Privy Council, it is very advisable to get the point well stated in anything that I say. Of course, I have not read this document yet. I should like to be satisfied, for instance, that it is covered by *Milne's* case.

Mr. TAIT: Yes. May I leave that for the moment?

HIS HONOR: Yes. There is further evidence, is there ?

Mr. TAIT: Yes—the documents exercising the options. Strictly speaking, I am not quite sure myself of the relevance of the exercise of the options after death, and may I say that I would be guided by Your 40 Honor's views on the matter. I do not know whether my friend would think they should not go in, as being irrelevant, but I am only anxious to complete the story. I cannot say more than that. They are not very lengthy documents and are all in the same form

HIS HONOR: I think it is advisable to put them in.

Mr. SMITH: I thought it might found an argument against Mr. Tait if they were not put in. Mr. TAIT: I will then adopt that course.

#### Reasons for Judgment of His Honour Mr. Justice $\label{eq:reasons}$ States---WILLIAMS. Dated 8th March 1949

HIS HONOUR. This is an appeal by the executors of the estate of Frederick Charles Henry Thomas who died on the 28th of January, 1944, from the assessment-by the respondent of his estate for the purposes of Federal Estate Duty under the provisions of the Estate Duty Assessment Originally a number of items in the assessment were Act. 1914–1942. objected to but the respondent has twice amended the original assessment 20 and has allowed all the objections except one.

The second amended assessment is dated 27th February 1948 and the Appeal is now an appeal from that assessment. The only item still in dispute relates to the interest of the deceased in a partnership business carried on under the name of Maples. There is a partnership agreement governing the rights of the parties dated 22nd December 1939 as amended by a further agreement dated the 4th December, 1940.

In the lifetime of the deceased there were seven partners, viz. the deceased, Robert Nathan, Louisa Jones, Lorna Hannan, Lionel Newton, Lauri Joseph Newton, Donald Lamond, and the deceased was survived by

30 the other six partners. The partnership agreement included options to these surviving parties other than Lamond, to purchase a share of the deceased in the capital of the partnership.

In the events that have happened these options were firstly to Louisa Jones and Lorna Hannan, an option to purhase  $6\frac{10}{400}$  of the interest of the deceased in the capital of the partnership, and secondly, to the other four partners, except Lamond, the option to purchase the residue of the interest of the deceased in this capital in proportion to their respective interests in the capital of the partnership.

The partnership agreement provided that in computing the amount 40 of the purchase money payable on the exercise of these options no sum should be added or taken into account for goodwill.

In the High Court of Australia.

No. 9. Judgment of Williams, J. 8th March, 1949 continued.

The five surviving partners have exercised their respective options and the question still at issue between the appellant and the respondent is whether the share of the deceased in the goodwill of the partnership at the date of his death, which the parties have agreed is of the value of  $\pounds 20,000$ , Reasons for forms part of his dutiable estate.

> The respondent, without giving up any other contentions open to him upon the true construction of the Act, contends that it forms part of his notional estate within the meaning of Section 8(4)(e) of the Act.

It seems to me necessarily to follow from Milnes Case, 69 C.L.R. 270 10 that this contention must succeed.

I must therefore order that the appeal be dismissed with costs.

No further questions arise, I think.

3.—The dutiable estate of the above-named Frederick Charles Henry Thomas deceased did not include any interest in the goodwill of the partnership which was formerly carried on by the said deceased and others under the name or style of "Maples" pursuant to an indenture of partnership made on December 22nd 1939.

4.—The said deceased did not at the time of his death have any 30 beneficial interest in the said goodwill which by virtue of the said indenture of partnership or otherwise passed or accrued on or after his death to or devolved on or after his death on any other person.

5.—That in assessing the value of the estate of the said deceased for the purposes of the Estate Duty Assessment Act 1914-1942 the Deputy Commissioner of Taxation wrongly added to the value thereof as returned by the Appellant the sum of  $\pounds 20,000$  as being the value of the beneficial interest in the goodwill of the said partnership which the said deceased had at the time of his death and which (as the Deputy Commissioner claims) is deemed to form part of the estate of the said deceased by reason of the 40 provisions of Section 8 (4) (e) of the said Act.

6.—The estate of the said deceased is not dutiable in respect of any part of the goodwill of the said partnership, either under Section 8 (4) (e) or any other provision of the Estate Duty Assessment Act 1914-1942.

#### REASONS FOR JUDGMENT OF THE FULL COURT OF THE HIGH COURT OF AUSTRALIA DELIVERED BY HIS HONOUR THE CHIEF JUSTICE ON 16th May 1949

It is conceded that this appeal must fail unless the Court is prepared to reconsider and to overrule the decision in *The Trustees Executors and Agency Company Limited* v. *The Federal Commissioner of Taxation*, 69 C.L.R. 270. The decisions of a superior court have a double aspect. They determine the controversy between the parties, and in deciding the case 10 they may include a statement of principle which it is the duty of that Court and of all subordinate courts to apply in cases to which that principle is relevant. Continuity and coherence in the law demand that, particularly in this Court, which is the highest court of appeal in Australia, the principle of *stare decisis* should be applied, save in very exceptional cases.

The Court is not bound by its previous decisions so as absolutely to preclude reconsideration of a principle approved and applied in a prior case but, as was stated in Cain v. Malone 66 C.L.R. 10, the exceptions to the rule are exceptions which should be allowed only with great caution and in clear cases. Barton J. in The Tramways case 18 C.L.R. 54 which 20 has been referred to by Mr. Tait, said at page 69: "I have never thought "that it was not open to this Court to review its previous decisions upon " good cause. The question is not whether the Court can do so, but whether "it will, having due regard to the need for continuity and consistency in "iudicial decision." His Honour proceeded to say: "Changes in the "number of appointed Justices,"-(and I would add, changes in the personnel of the bench which happens to deal with the first case or a second case)—" can, I take it never of themselves furnish a reason for review." His Honour continued : "But the Court can always listen to argument " as to whether it ought to review a particular decision, and the strongest 30 " reason for an overruling is that a decision is manifestly wrong, and its "maintenance is injurious to the public interest." In the present case, there are no circumstances which would justify, in accordance with those principles, an overruling of the decision in The Trustees, Executors case. The only circumstance which is really relied upon for the purpose of persuading the Court to reconsider the decision is that it was a majority This is plainly an insufficient ground for asking the Court to decision. overrule a previous considered decision of five justices. It may be that considerations are present in constitutional cases, where Parliament is not in a position to change the law, which do not arise in other cases. In 40 what I have said I make no reference to constitutional cases. The consequence is that, if the Court adheres, as it should, to the decision in The Trustees, Executors case the appeal must fail.

The appeal should, therefore, be dismissed with costs.

Appeal from the High Court of Australia between the Petitioners Appellants and The Commissioner of Taxes of the Commonwealth of Australia Respondent setting forth (amongst other matters): that the Petitioning Company is the Executor of the estate of the late Frederick Charles Henry Thomas who died on the 28th January 1944 and in that capacity the Petitioning Company lodged an objection under Section 24 of the Commonwealth Estate Duty Assessment Act 1914-1947 against an assessment to estate duty made under that Act by the Commissioner of Taxes in respect of the estate of the deceased on various grounds of which one only became the subject 10 of appeal to the High Court, viz. : that the assessment wrongly treated as included in the assessable estate the value of a share in the goodwill of a partnership of which the deceased was a member : that the share of the deceased in the capital of the partnership was on his death taken over by other partners under an option contained in the Partnership Agreement at a price that was to include and did in fact include nothing in respect of goodwill and the partnership agreement contained no express provision for the devolution of the Deceased's share of goodwill on his death : that the only question for decision in the proceedings is whether in the foregoing circumstances the value 20 of his former share of goodwill enters into the estate of a deceased partner assessable to Estate Duty: that this question arose in substantially identical circumstances in the case of Trustees Executors & Agency Company Limited v. Federal Commissioner of Taxation (1944) 69 C.L.R. 270) (thereinafter called the Milne case) and was there decided in favour of the Commissioner by the Full Court of the Commonwealth by a Majority of three against two: that the present Petition seeks to obtain a review of the decision in that case : that by virtue of Section 24 of the Estate Duty Assessment Act the objection lodged by the Petitioning Company was treated as an Appeal to the 30 High Court and this Appeal was heard and dismissed without discussion of the merits on the 8th March 1949 : that the Court simply followed the decision in the *Milne* case : that the Petitioning Company appealed to the Full Court which refused to reconsider the decision in the Milne case and this Appeal was also on the 16th May 1949 dismissed without consideration of its merits : And humbly praying Your Majesty in Council to grant the Petitioners special leave to appeal from the Judgment of the High Court dated the 16th May 1949 and for such other Order as to Your Majesty in Council may seem fit :
