About 20 years ago the Plaintiff was given a piece of land by the then Bantamahene on which he erected a Compound House. Neither Kwame Kyem, the then Bantamahene nor any of his successors ever demanded ground rent from the Plaintiff and the Plaintiff has never at any time paid ground rent to any one.

The Plaintiff left his Compound House in Kumasi in charge of one John Mensah and stayed in the Bush, and through him the Plaintiff has been paying his Town rate of £2 a year regularly.

On the Plaintiff's return to Kumasi he was made to understand his Compound House has been sold by the 1st Defendant through the 2nd Defendant, that the 3rd Defendant was the Auctioneer and the 4th Defendant the Purchaser.

the Court under Order 43 Rules 26 and 27(a) for leave to issue execution against Elizabeth Anima and against Nana Kwaku Gyawu III the Bantamahene in substitution for Kwame Amankwatia, now deceased.

The following were the facts before me.

On the 10th November, 1938 Kwame Dwaaissued out of this Court a Writ of Summons claiming as against Kwame Amankwatia, Elizabeth Anima and two others a declaration of title to leasehold premises at No.23 Bantama, Kumasi and £120 damages for trespass, wrongful sale, use and occupation.

The particulars of claim which have been reiterated before me and which were not denied are that sometime about 1918 the then Bantamahene gave to Kwame Dwaa a piece of land upon which he built a house and occupied it free of rent. He left Kumasi and whilst away left the house in charge of a John Mensah. During his absence the then Bantamahene sold the house to Elizabeth Anima, where upon the plaintiff Kwame Dwaa issued his writ.

On the 23rd March, 1939, a consent judgment was entered into by the parties before Bannerman, J. The terms of that judgment were that Kwame Amankwatia the then Bantamahene was to pay to Elizabeth Anima the sum of £30.2.0. being the purchase price of the house within a fortnight, and that Elizabeth Anima was to give up possession of the house within that same period, and within that same period Kwame Dwaa was to pay to the Bantamahene a sum of £11.16.0. He was further to pay to Elizabeth Anima a sum of £7 upon production by her of the receipts for the ground rents.

But on the 24th July, 1939, Elizabeth Anima moved Bannerman, J. to construe the order made on the 23rd March, 1939, and to give directions, supporting her motion by an affidavit setting out that Kwamo Dwaa had failed to pay the £7 and that the Bantamahene had failed to pay the sum of £30.2.0.

Bannerman, J. then made the following order:-

"If the 1st Defendant (Bantamahene) has failed within the time limit to pay the £30.2.0. to the 4th Defendant (Elizabeth Anima) should retain possession of the house."

All parties were present including Mr.E.Brown, Counsel for the Plaintiff. No directions were given with regard to the position of Kwame Dwaa. This quite clearly was a variation of a consent judgment and it is quite clear upon the record that there was no consent by Kwame Dwaa to the variation of the order, and I think for the reason that its implications and results were not realized at the time, no appeal against this order was made.

But the matter ambiguous as it appeared there, 10 is further complication (sic) by a letter written on the directions of the learned Judge to "Akosua Mansah on behalf of her daughter Elizabeth Anima" and which reads:-

"I do not see on what grounds the purchaser has been sued in a Native Court for rent in respect of the house since the order of the Divisional Court stands and is binding on all the parties. Furthermore the sale of the house has not been set aside by this Court as evidenced by the consent Judgment. Any decision therefore against the purchaser by any Native Court would be contrary to the terms of the consent judgment and would assume to set aside or override a judgment of the Supreme Court.

Upon these facts it appeared to me that it was the intention of the learned Judge that the sale of the house to Elizabeth Anima had not (sic - been) set aside by the consent judgment and that as certain conditions had not been fulfilled by Kwame Dwaa and the Bantamahene that the possession of the house should remain with Elizabeth Anima.

However inexplicable such a result I was of the opinion that it was a judgment by a brother Judge which could not be overruled by me and that in consequence, Kwame Dwaa could not now issue execution for possession of the house against Elizabeth Anima, and I dismissed the motion.

On the 18th March upon the application of Kwame Dwaa I consented to review that decision, a decision which was certainly very disturbing to me as I felt that the facts not being in issue there did appear to have resulted a miscarriage of

justice, and what the Courts do try to do is to ascertain the truth and do justice.

That the Bantamahene did sell to Elizabeth Anima property which was not his to sell is clear and in circumstances which have never been denied, it savoured strongly of a fraud having been perpetrated upon Kwame Dwaa by a Chief who stands only second in rank to the Asantehene himself, and this fact must not be lost sight of when viewing the conduct of all the parties and the delay in enforcing their remedies.

If that consent judgment meant anything at all surely one thing is crystal clear and that is that the parties agreed upon certain terms that the sale should be set aside and that Kwame Dwaa should be placed again in the same position as he was before his house was sold behind his back, and upon second thought I must regard the learned Judge's letter as being extra-judicial and not as words which should be construed as a part of his judgment.

If any one of the parties had failed to carry out his or her part of the consent judgment then they could issue execution for its enforcement and that was the remedy open to them and not by asking the Court to do as it did do in effect and seek to vary a consent judgment.

Now has it varied its judgment so as to prevent Kwame Dwaa applying for and obtaining as against Elizabeth Anima a writ of possession.

All that the learned Judge said was that if the Bantamahene failed within the "time limit" to pay the £30.2.0. to Elizabeth Anima that the later (sic) should retain possession of the house.

But in those directions no limit was placed upon the words "time limit". It clearly had no reference to the limits in the consent judgment entered on the 23rd March, 1939 since the time limits mentioned there had passed long before the hearing of this motion on the 24th July, 1939.

It was then a limitless "time limit" and provided that Elizabeth Anima recovers the sum of £30.2.0. and that she surrenders to Kwame Dwaa the receipts for ground rents in exchange for £7. She

will be in precisely the same position as to one to which she consented on the 23rd March, 1939.

Elizabeth Anima argues that she has spent £400 in repairs to the house. Against this she has engaged (sic) its use and its profits for more than 10 years.

Kwame Dwaa tells me he did not issue execution for all these years because he was sick. A native of Ashanti is very reluctant to say anything that may reflect upon the character of a Chief and especially one of such importance in Kumasi as is the Bantamahene. The conduct of the late Bantamahene was frankly dishonest. He sold Kwame Dwaa's property when he knew he had no right to do so. He consents to pay Elizabeth Anima what she paid for the house at the sale to enable Kwame Dwaa to recover back his property, and his failure to do so was not only dishonest but savours strongly of collusion between himself and Elizabeth Anima to defeat a judgment to which they had consented and upon which they escaped on very easy terms.

I should be doing far less than justice if I did not amend my decision given on the 22nd February, and I do amend it in the following terms at the request of the applicant.

Upon payment into Court of a sum of £30.2.0. to be deposited in favour of Elizabeth Anima the applicant may issue execution against the said property at No.23 Bantama, Kumasi.

There is no matter before me however on which the applicant can go into execution as against the Bantamahene.

The applicant is entitled to the costs of these proceedings which I assess at 2 guineas as against Elizabeth Anima.

### JUDGMENT

Foster-Sutton, P. FOSTER-SUTTON, P.: In this case the Plaintiff claimed for a declaration of title to a compound house situate on leasehold premises in Kumasi, and for £120 damages for trespass.

Shortly put the facts are as follows :-

The land in question was sold to the Plaintiff by the first defendant. The plaintiff then left

the district for a number of years and while he was away, the Bantamahene, that is to say, the first defendant, purported to convey the property to the fourth defendant, without the knowledge or consent of the plaintiff. Those facts were not disputed in the Court below.

The action came before Woolhouse Bannerman, J. on the 23rd March, 1939, and a consent Judgment was entered, all the parties were before the Court. The first condition of the Judgment entered by consent reads as follows:

"The 4th defendant is to give up possession of "the house in dispute within a fortnight from "today's date."

The plaintiff withdrew his case for damages and his claim against the second and third defendants, but it is relevant to note that there was no suggestion that he had withdrawn his claim for a declaration of title to the premises in dispute.

As has been pointed out by my brother Sir Henley Coussey, the first paragraph of the consent Judgment makes it abundantly clear that the plaintiff in fact persisted in his claim for the declaration he had sued for. The fourth defendant was ordered to give up possession without any condition being attached, and the order could only have been made on the footing that the plaintiff was the legal owner.

The matter came before the Court again on the 24th July, 1939, on a Motion filed by the fourth defendant, under which she claimed a review of the Judgment I have just referred to. The learned trial Judge, upon that Motion, made the order which is set out at page 12 of the record. Having regard to the fact that the previous Judgment was a consent one, in my view, he had no power to review that Judgment unless the consenting parties agreed to such review, and there is no indication that they did so.

The plaintiff could have proceeded to execution on the consent Judgment as also could the fourth defendant against the first defendant, and had she, after production of the receipts, failed to recover the £7, referred to in paragraph 7 of

the consent Judgment, she could have proceeded to execution against the plaintiff for that sum. The plaintiff let the matter rest for a number of years and the learned trial Judge against whose Judgment this appeal has been brought has suggested a reason as to why that was done. Be that as it may, under the Rules, having taken no further steps for over six years, when he ultimately decided to enforce the Judgment he was compelled to do what he did, that is to say, file a Motion for leave to proceed to execution.

In my opinion Jackson, J. had jurisdiction upon that Motion to deal with the matter as he did As has already been pointed out by a member of this Court, that part of his order which requires payment of the sum of £30.2.0. is doubtful, but he was entitled to give leave to the plaintiff to proceed to execution.

A point has been raised and argued very strongly, as indeed he had the right to do. by Counsel appearing on behalf of the fourth defendant-appellant. He argued that, as under section 17 of Chapter 4 the Divisional Court is required not to exercise its jurisdiction in cases such as this, the original Judgment of Woolhouse Bannerman, J. was of no effect because he ought to have transferred the case to the Native Court. in the circumstances of this case, apart from any question of waiver by the parties where the Court has inherent jurisdiction, the fourth defendantappellant cannot, after the lapse of over 10 years, when she herself has taken steps under the consent Judgment, now be heard to say that the Court had no jurisdiction in the matter. Such an argument is only calculated to defeat justice and indeed create injustice.
