Respondents' Supplementary Case.

- 1. Paragraphs 29 33 of the Appellants' Case setting out an account of the law of priorities in France, Belgium, the Netherlands and West Germany have not previously been introduced in argument, nor has any evidence been adduced to support the facts alleged.
- 2. The Respondents object to the introduction of fresh evidence before the Judicial Committee of the Privy Council.
- 3. Alternatively the Respondents will contend
- a) as to paragraph 31 lines 41-43 which asserts that in Dutch law a mortgagee has priority over a claimant who has supplied goods or carried out repairs to the ship is contrary to certain decisions of the Courts of First Instance in Rotterdam, Haarlem and Middleburg.
- b) as to paragraphs 29 and 30 French and Belgian law the nature of a maritime lien is materially different in France, and it is thought also in Belgium, in that a maritime lien does not give rise to an action in rem nor does it survive even as a right to arrest the ship once the ship has been sold to a bona fide purchaser and the sale publicised.
