ON 23rd February, 1978, FRANCIS JOHN KELLY of 285 George Street, Sydney in the State of New South Wales, Regional Manager, says an oath:-

- 1. I am the Regional Manager of the Plaintiff and am duly authorised to make this Affidavit.
- 2. On 4th April, 1974 the Plaintiff by Deed bearing that date (hereinafter called "the Principal Deed") agreed with Tacking Point Downs Pty. Limited ("the Borrower") and other associated or interested parties to furnish to the Defendant a "Take-Out Guarantee" in consideration, inter alia, of a covenant by such parties for payment quarterly of a fee (hereinafter called "the commitment fee"). Annexed hereto and marked "A" is a copy of the said Deed.
- 3. On 4th April, 1974 the Plaintiff furnished to the Defendant the said Take-Out Guarantee in the form of a letter bearing that date from the Plaintiff to the Defendant. Annexed hereto and marked "B" is a copy of the said letter.
- 4. On or about 1st May, 1974 the Defendant wrote to the Plaintiff confirming that the quantum of the liability under the Take-Out Guarantee would be reduced to the figure of \$1 million. Annexed hereto and marked "C" is a copy of such letter. As appears therefrom the Defendant did not, contrary to Recital C in the said letter annexure "B" hereto, acquire a first mortgage over the area of 56 acres. In fact the Bank's mortgage over the said area comprises a Third Mortgage.

The Borrower is the registered proprietor of the parcels of land at Port Macquarie described in Part A of the First Schedule hereto and has negotiated the purchase of the parcels of land at Port Macquarie described in Part B of the First Schedule hereto. The parcels of land described in Parts A and B of the First Schedule hereto are hereinafter referred to as "the Port Macquarie lands."
- B. The Borrower has requested THE AUSTRALIA & NEW ZEALAND BANKING GROUP LIMITED (hereinafter called "the Bank") to make certain loan facilities available to the Borrower on the security of (inter alia) a registered first mortgage or mortgages over the Port Macquarie lands and a floating charge over the Borrower's assets (which securities are hereinafter referred to as "the Bank's securities").
- C. It is a condition of the Bank's said agreement that the Borrower provide a guarantee to the Bank that finance up to a maximum amount of One Million one hundred thousand dollars (\$1,100,000.00) will be available to the Borrower to enable it to repay in part or in whole the Bank's loan when that loan falls due for repayment (hereinafter referred to as "the take-out guarantee").
- D. Beneficial has at the request of the Borrower, the Guarantors and the Sureties agreed to provide the take-out guarantee on the terms and subject to the covenants and conditions hereinafter set forth.
- NOW THIS DEED WITNESSETH and it is hereby mutually agreed and declared as follows:-
 - 1. BENEFICIAL agrees with the Borrower, the Guarantors and the Sureties that Beneficial will

provide to the Bank a take-out guarantee in the form of the draft letter from Beneficial to the Bank annexed hereto and signed by the parties for the purposes of identification.

- 2. BENEFICIAL'S obligation to the Bank under the take-out guarantee shall be subject to the terms of the said draft letter and shall arise only if the conditions set forth therein and in this Deed shall have been duly fulfilled and the commitment fee provided for in Clause 3 hereof shall have been duly paid.
- IN consideration of Beneficial agreeing to provide the take-out guarantee as aforesaid the Borrower and the Guarantors covenant and agree with Beneficial that the Borrower shall pay to Beneficial a commitment fee equivalent to One per centum (1%) per quarter calculated by reference to the maximum amount owing by the Borrower to the Bank during each quarterly period for so long as the 20 take-out guarantee subsists. The Borrower shall pay to Beneficial at the commencement of each quarterly period a fee calculated by reference to the amount owing at the commencement of the quarter and at the expiration of the quarter shall make such further payment as may be necessary to bring the amount paid up to the figure of One per centum (1%) per quarter hereinbefore referred to
- 4. IT is a condition of Beneficial's assumption of the obligation contained in Clause 1 hereof that on the execution hereof or at such other time as Beneficial may in writing agree Beneficial shall have the benefit of the securities from the Borrower, the Guarantors and the Sureties described in the Second Schedule hereto (which are herein referred to as "Beneficial's securities) by way of security for:-
- (a) The commitment fee payable by the Borrower pursuant to Clause 3 hereof;
- (b) Any other moneys payable by the Borrower to Beneficial hereunder; and 40
- (c) Any moneys which may be advanced by Beneficial to for or on account of the Borrower in pursuance of the obligation assumed by Beneficial in Clause 1 hereof.
- 5, IN the event of Beneficial being called upon under Clause 1 hereof to pay out the Bank's loan then upon such payment being made Beneficial shall (in addition to Beneficial's securities as hereinbefore described) be entitled to take the benefit of the Bank's securities in one or other of the following manners:-

- (a) Beneficial may require the Bank to assign its securities and the full benefit and advantage thereon to Beneficial (as on the assignment of a mortgage debt); or
- (b) Bemeficial may require that the Bank discharge its securities and that the Borrower and the Guarantors execute fresh securities in favour of Beneficial in the form of firstly a first mortgage over the Port Macquarie lands, secondly a floating charge over the Borrower's assets and undertaking including uncalled capital and thirdly a deed of guarantee from the Guarantors, such securities to be in such form as Beneficial's Solicitors shall in their absolute discretion require

- 6. THE terms of repayment by the Borrower in respect of any moneys advanced by Beneficial to for or on account of the Borrower in pursuance of Clause 1 hereof shall be as follows:-
- (a) The capital sum advanced shall be repaid on or before the expiration of two (2) years from the date on which the same is provided by Beneficial as aforesaid;
- (b) The Borrower shall pay to Beneficial interest on the said capital sum at the rate of fourteen per centum (14%) per annum or such other rate as Beneficial in its absolute discretion considers to be the rate of interest then prevailing for transactions of this nature, such interest to be computed from the date upon which the capital is paid out by Beneficial and calculated on daily rests and payable on monthly rests.

BY way of further consideration for Beneficial agreeing to provide the take-out guarantee as aforesaid the Borrower agrees that in the event of Beneficial being called upon so to do and providing finance to pay out the Bank as provided in Clauses 1 and 8 hereof then the Borrower shall become liable to pay to Beneficial in addition to the capital sum and interest hereinbefore provided a further sum equivalent to Twenty-five per centum (25%) of the net profit (calculated as hereinafter provided) derived by the Borrower from the development of the Port Macquarie lands. The Borrower's profit as aforesaid shall be calculated on the basis set forth in the Third Schedule hereto. Any dispute between the parties as to the amount payable by the Borrower to Beneficial under this Clause shall be referred to an arbitrator appointed by the President for the time being of the Australian Institute of Chartered Accountants (New

- BENEFICIAL further agrees with the Borrower that in the event that the Bank during the term of its loan advances to the Borrower a further loan (hereinafter called "the development loan") to assist the Borrower in developing the Port Macquarie lands then PROVIDED that there shall not at the time the development loan or the first instalment thereof is advanced by the Bank be any breach or non-observance of the terms of this Deed by the Borrower or the Guarantors or the Sureties, Beneficial shall extend its take-out guarantee to the Bank so as to include the quantum of the development loan subject to the same terms and conditions as are hereinbefore expressed or are expressed in the draft letter to the Bank in relation to the Bank's initial loan of the principal sum and to the following further terms and conditions:-
- (a) Beneficial's additional liability under the take-out guarantee in respect of the development loan shall not exceed the sum of Nine hundred thousand dollars (\$900,000.00).
- (b) The development loan shall be advanced by the Bank only by progress payments equivalent to expenses actually incurred by the Borrower in developing the said lands by residential subdivision.
- (c) The Borrower's development plan for the residential subdivision of the said lands shall have been duly approved by the Council of the Municipality of Port Macquarie and the State Planning Authority of New South Wales (or any authority appointed or established in substitution therefor) and any other statutory local or other authority whose consent or approval to the plan is necessary for such purposes and there being no legal or other impediments to the development of the said lands by residential subdivision.

We refer to our letter to you dated 4th ultimo covering the take-out arrangement for Tacking Point Downs Pty. Limited.

We advise that we have no objection in principle to the Bank taking a registered second mortgage over the 56 acres of land at Port Macquarie being purchased by Tacking Point Downs Pty. Limited from Mr. E.J. Carving with the Vendor carrying a first mortgage of \$100,000.00 on the security of the land.

However it should be noted that this does have an indirect effect on our take-out arrangement, in that the Bank's security is affected. Accordingly, if at the time the take-out becomes operative the first mortgage to the Vendor is still on foot then our liability in respect of the take-out should have a limit of \$1,000,000.00 in lieu of \$1,100,000.00 because the Bank's security will effectively be worth \$100,000.00 less. I understand that in addition to covering the development and associated costs of the initial phase, plus holding costs and guarantee fee, an indemnity/guarantee for \$170,000 will now be required in favour of The Council of the Municipality of Port Macquarie. The additional \$20,000 represents 10% retention of development works and will remain until three months after completion of contracted works. However, it is still understood the indemnity/guarantee will not be required until after initial progress payment is due and/or development expenditure exceeds \$50,000.

Prior to each progress payment being made to Richini Constructions, I understand it is still envisaged that Council will inspect works against Architects Certificate and issue a letter reducing amount of the indemnity/guarantee. In effect it is expected that the exposure for the development contract, relating to Overdraft \$495,000 and increased indemnity/guarantee \$170,000 will never exceed \$556,000, in aggregate at any one time.

We acknowledge receipt of your letter of the 19th December, 1977.

The terms of the letter and the circumstances leading to its despatch have caused us to critically examine our position. Accordingly, we must point out that there has occurred non-fulfilment with the condition contained in Clause 4 of the Undertaking of 2 March 1976 and that accordingly, our liability under Clause 1 to "take-out" cannot and will not be accepted on our part. The non-fulfilment comprises at least the non-payment of the last commitment fee to fall due and payable under the terms of the relevant Agreement with the Borrower on 4 January, 1978.

In addition to Clause 4, there has occurred non-fulfilment of the following further contractual conditions:

- (i) That contained in Clause 6 of the 2 March 1976 Undertaking, relating to the giving to us of notice specifying defaults. You would doubtless be aware of all relevant defaults. No notice thereof has ever been given to us.
- (ii) That contained in Clause 2 of the letter of undertaking dated 4 April 1974, as preserved by Clause 3 of the 2 March 1976 Undertaking, relating to the making of further advances without our consent. Again, you would doubtless have full details of such advances.
- (iii) That contained in the second proviso to Clause 1 of the 2 March 1976 Undertaking relating to acts or omissions diminishing or impairing the value or effectiveness of the Bank's securities.

Additionally, contrary to Recital B contained in the letter of 4 April 1974, no floating debenture charge over the assets and undertakings of the Borrower then existed, nor was in fact obtained until 23 December 1975; both of the undertakings referred to in this letter were predicated, whether expressly or by implication, on the charge having been in existence on or before 4 April 1974 and upon such charge being ultimately available for transfer contemporaneously with "take-out".

For the foregoing and any other grounds which may be presently available to us, we repeat that we must decline liability to "take-out" under Clause 1

We acknowledge receipt of your letter of the 7th instant indicating that your Company intends to deny liability to make payment to the Bank pursuant to the Letter of Take Out dated 4th April 1974 and subsequent amendments to the same which were executed by your Company.

With respect to the various matters raised in your letter of the 7th instant as reasons why your Company considered it was not under liability to the Bank we reply as follows:

- With regard to your statement that the last commitment fee due on 4th January, l. 1978 has not been paid it is noted that you did not inform the Bank of this before your letter of the 7th instant, and further, that as your Company is required under account authority to countersign all cheques of Tacking Point Downs Pty Limited your Company had adequate means of seeing that payment was made at the correct time or of informing the Bank if it was not. Pursuant to Clause 4 of the amending Agreement of 2nd March 1976 we have endeavoured to arrange issue of a cheque to cover the amount of the Commitment Fee to 4/1/78 but our efforts have been thwarted by your refusal to allow issue of a cheque form from the book which is held by you and in terms of the Bank Authority we are aware that such cheques are to be countersigned by officers of your Company.
- 2. With regard to the giving to your Company under Clause 6 of the amending Agreement of 2nd March 1976 notice of defaults under the securities held by the Bank, we would enquire what defaults your Company alleges have occurred. The Bank, not having had notice of any defaults under the securities, has not been required to give any notice of defaults to your Company.
- 3. With regard to the suggestion that the Bank has made further advances to Tacking Point Downs Pty Limited without your Company's consent, this is emphatically denied. Your Company has at all times been aware of increases granted and its representatives in fact have been involved with the interviews held with the Bank to arrange increases. Your Company's representative actually signed acknowledgement and confirmation of the last arrangement for increase contained in the Bank's letter to your Company of 10th August 1977.
- 4. With regard to the suggestion that the Bank has by its acts or omissions impaired the value or effectiveness of the Bank's securities, this is also emphatically denied. We would suggest that you specify such acts and omissions of the Bank as your Company alleges have occurred and have had the effect abovementioned.

Your letter of the 14th February reached us on the 17th. We maintain that we have properly disclaimed liability despite your assertion to the contrary. So that there be no misunderstanding as to our present position, we comment on the points raised by you as follows:-

1. It was the obligation of the Bank, not this Company, to ensure payment by due date of commitment fees from your borrower and our officers only became signatories to the No. 3 Account at your insistence. It is quite wrong to suggest that we thwarted any attempt on your part to procure payment of commitment fee by withholding the cheque book.

The borrower did present a cheque to us late last Friday afternoon and we have returned it unsigned re-confirming our request that the previous bank authority involving our officers be withdrawn by reason of our disclaiming liability under the arrangements that had previously existed between us.

2. You are referred to your registered securities, the terms thereof, and each and every default thereunder of which we have not received notice.

3 & 4. We are at issue.

- 5. The letter of take-out dated 4th April 1974 was furnished at the request of the Bank and it was a condition that there would be included in the Bank's securities an Equitable Charge that it did not ultimately take until 23rd December 1975. This Company's position was thereby prejudiced. Whilst the Bank might not have been a party to the second amending take-out letter it clearly is bound by the terms of that document.
- 6. The breaches by the Bank are of such a fundamental and continuing nature that they are not negated by the alleged waiver.

As you do not appear to accept our position we have no alternative but to institute proceedings for declaratory relief and will do so forthwith.

- (b) I am informed and verily believe that the first notification received by the Bank that the commitment fee due on 4th January 1978 had not been paid by the Borrower to Beneficial was in Beneficial's letter to the Bank dated 7th February 1978 (Annexure "AA" of the Affidavit of F.J. Kelly filed herein).
- (c) I am informed by Mr. E. Myatt, a Bank officer under my control, that on 14th February 1978 40 he telephoned Mr. B. Flood, secretary and a director of the Borrower, requesting Mr. Flood to issue to Beneficial a cheque in payment of the commitment fee, namely \$14,402.82. I am further informed by Mr. Myatt that Mr. Flood on that day went to the offices of Beneficial who at that time had possession of the relevant cheque book and that an officer of Beneficial refused to hand a cheque form to Mr. Flood.

(Amended pursuant to leave granted by Mr. Justice Meares on 28th September 1978)

- l. By letter bearing date 4th April, 1974 the Plaintiff undertook to the Defendant that in the event of the Defendant's liability in respect of the Defendant's loan (as therein defined) to Tacking Point Downs Pty. Limited (therein and hereinafter referred to as "the Borrower") not being satisfied on or before the expiration of two (2) years from the date thereof, the Plaintiff would upon receipt of ninety (90) days' notice in writing from the Defendant "take-out" (as therein defined) the said loan. A true copy of the said letter dated 4th April, 1974 is annexed to these Points of Claim by way of schedule hereto and is hereinafter referred to as the "1974 Undertaking".
- 2. By letter bearing date 1st May, 1974 the Plaintiff consented to a variation of the 1974 Undertaking conditional upon its liability thereunder being limited to \$1,000,000.00 in lieu of \$1,100,000.00 as provided in the 1974 Undertaking. A true copy of the said letter dated 1st May, 1974 is annexed to these Points of Claim by way of schedule hereto.
- 3. By divers letters thereafter written by the Plaintiff to the Defendant, the Plaintiff agreed to various extensions to the said time for take-out, the last such time being 22nd May, 1976.
- 4. By instrument under seal executed by the Plaintiff on or about 2nd March, 1976, the 1974 Undertaking was varied whereby the Plaintiff undertook to the Defendant that in the event of the Borrower's liability to the Defendant in respect of the principal (as therein defined) not being totally discharged and satisfied on or before 31st March, 1978, the Plaintiff would at the expiration of ninety (90) days' notice in writing from the Defendant forthwith pay to the Defendant the whole

(cont'd) of the principal then owing together with all bank interest on the principal and all bank charges of and incidental thereto owing to the Defendant by the Borrower, subject to the limitation of liability on the Plaintiff's part as in Clause 2 thereof set forth. A true copy of the said instrument under seal executed on or about 2nd March, 1976 is annexed to these Points of Claim by way of schedule hereto and is hereinafter referred to as the "1976 Undertaking".

5. By letter bearing date 10th August, 1977 written by the Defendant to the Plaintiff and acknowledged and confirmed at the foot thereof by the Plaintiff, the Defendant gave notice of approval of the increased facilities to the Borrower as therein set forth. One effect of the said letter as between the Plaintiff and the Defendant was to limit the liability of the Plaintiff to the Defendant under the 1976 Undertaking to the sum of \$1,600,000.00. A true copy of the said letter dated 10th August, 201977 is annexed to these Points of Claim by way of schedule hereto.

- 6. As appears by Clause 3 of the 1976 Undertaking it was thereby provided that the terms of the 1974 Undertaking should continue to apply save as varied by the 1976 Undertaking.
- 7. (a) By the 1974 Undertaking it was recited that the loan was secured interalia by a floating debenture charge over the assets and undertakings of the Borrower, meaning thereby that a security of such description was then in existence and held by the Defendant as Mortgagee from the Borrower as Mortgagor;
- (b) It was a condition precedent to the Plaintiff's liability under the 1974 Undertaking that the Defendant should in exchange for satisfaction of its said liability transfer and assign to the Defendant inter alia a floating charge of the said description, that is to say, a floating charge in existence on or prior to 4th April, 1974 given by the Borrower as Mortgagor in favour of the Defendant 40 as Mortgagee.

By reason of all the facts alleged in paragraphs 5 to 12 of the amended Points of Claim the Cross Defendant says that it is under no liability to the Cross Claimant or alternatively the limit of any such liability on the Cross Defendant's part is One million six hundred thousand dollars (\$1,600,000.00).

JUDGMENT

HIS HONOUR: The plaintiff seeks a declaration that it is not liable to the defendant pursuant to a letter written by the plaintiff to the defendant on 4th April, 1974. The terms of the letter (in the language of the parties described as a take-out letter or guarantee) were varied by a further letter dated 1st May, 1974 and by a notice to the defendant dated 2nd March, 1976. By its cross-claim the defendant seeks a declaration that the plaintiff is liable to it under the letter and judgment for the amount which it claims to be due. The issues raised by the claim and the cross-claim are similar, subject to there being a question as to

the amount to be paid by the plaintiff to the defendant if the defendant is entitled to succeed. That question has been left to be dealt with after I have published reasons for judgment on the question of whether or not the plaintiff is liable under the letter. I propose, therefore, to decide the matters which were argued in relation to that question and to publish reasons for those decisions, but I shall not make any final declaration or order until counsel have had an opportunity of considering what I have said and putting submissions, in the event that agreement cannot be reached, in relation to the amount which would be payable if the defendant were correct.

By a deed dated 4th April, 1974 made between a company Tacking Point Downs Pty. Limited (hereinafter called "Tacking Point Downs"), a Mr. J.V. Dulhunty, a number of other companies and the plaintiff, the plaintiff agreed to provide the takeout letter, the construction of which is here in question, for Tacking Point Downs, Mr. Dulhunty and the other companies mentioned in the deed. defendant was not a party to the deed but the recitals thereto establish that it had agreed to make "certain loan facilities" available to Tacking Point Downs on the security of a number of mortgages and of a floating charge over the assets of Tacking Point Downs. It was a condition of the defendant's agreement to provide the financial accommodation that. Tacking Point Downs provide the defendant with a guarantee from another person or company guaranteeing the repayment of what was owed to it. The plaintiff had agreed to provide the guarantee (the take-out letter) upon the terms provided for in the deed.

Clause 1 of the deed provided that the plaintiff agreed with the other parties to the deed that it would provide to the defendant"a take-out guarantee" in the form of the draft letter from the plaintiff to the defendant which was annexed to the The letter annexed to the deed is in terms identical with the letter which was in fact written by the plaintiff to the defendant on 4th April, Clause 3 of the deed provided for the payment 1974. by Tacking Point Downs to the plaintiff of a commitment fee as therein provided for. when the fee was to be paid were also specified. Clause 4 of the deed provided that it was a condition of the plaintiff's assumption of the obligation provided for in cl. 1 of the deed that on the execution of it the plaintiff should have the benefit of the securities from the other parties to the deed as described in the second schedule thereto by way of security for the commitment fee payable pursuant to cl. 3, any other moneys payable by Tacking Point Downs to the plaintiff and any moneys

The letter of 4th April, 1974 was addressed by the plaintiff to the Senior Manager, Corporate Accounts, of the defendant in Melbourne. It was headed "Tacking Point Downs Pty. Limited & Ors. - Letter of Undertaking". There then followed four recitals which were as follows:

- "A. WHEREAS Australia & New Zealand Banking Group Limited (the Bank) has agreed to provide loans, commercial bills and other banking accommodation to Tacking Point Downs Pty. Limited (the Borrower) up to a maximum amount of \$1.1 million (the loan).
- B. AND WHEREAS the loan is secured (inter alia) by a registered first mortgage over 107½ acres approximately owned by the Borrower at Port Macquarie and a floating debenture charge over the assets and undertakings of the Borrower.
- C. AND WHEREAS the Borrower is acquiring an additional 56 acres of land at Port Macquarie which land will be subject to a first mortgage to the Bank.
- D. AND WHEREAS as a condition precedent to the granting of the loan the Bank has requested this letter of undertaking from Beneficial Finance Corporation Limited (Beneficial)."

The principal obligation imposed by the letter upon the plaintiff is to be found in par. 1 which is as follows:

"In the event of the Bank's liability in respect of the loan not being satisfied on or before the expiration of two (2) years (the expiration date) from the date hereof Beneficial undertakes upon receipt of ninety (90) days notice in writing from the Bank to pay or otherwise make such arrangements (the take-out) as are satisfactory to the Bank to discharge the liability to the Bank under the said loan PROVIDED HOWEVER that upon Beneficial providing the take-out the Bank transfers and assigns its interest in the Bank's said Mortgages over the $107\frac{1}{2}$ acres and 56 acres at Port Macquarie and the floating debenture

charge as aforesaid to Beneficial in a manner and form satisfactory to Beneficial and its solicitors AND PROVIDED FURTHER that the Bank shall not during the term of its loan have done or omitted to do any act matter or thing (whether in the way of exercising or omitting to exercise any of the powers conferred on the Bank by the Bank's securities or otherwise) as a result of which act or omission the value or effectiveness of the Bank's securities shall have been in any way diminished or impaired (save in the manner contemplated by paragraph 3 hereof)."

Paragraph 2 of the letter was as follows:

"Beneficial agrees that it shall provide the take-out as outlined herein subject to its liability not exceeding \$1.1 million and the only debits which the Bank shall be entitled to charge up against its loan shall be normal banking charges relative thereto and the Bank shall not be entitled to make any further advances to the Borrower in respect of the loan without Beneficial's prior approval in writing nor shall the Bank be entitled to charge up to the Borrower's loan account any interest on the loan."

It is unnecessary to refer to the remaining paragraphs of the letter.

The Plaintiff's letter to the defendant of 1st May, 1974 had the effect of reducing somewhat the contingent liability of the plaintiff under the letter of 4th April, 1974. Its notice of 2nd March, 1976 needs to be read in conjunction with a deed dated 2nd March, 1976 made between the same parties as the earlier deed of 4th April, 1974. The recitals to the deed referred to the earlier deed and to the fact that the plaintiff had, at the request of the other parties to the deed, agreed to vary the terms of the "take-out guarantee" given by the plaintiff to the defendant "so as to cover increased financial accommodation" given by the defendant to Tacking Point Downs. Clause 1 of the deed provided that the plaintiff at the request of the other parties agreed to provide to the defendant an amended take-out guarantee in the form of the draft letter from the plaintiff to the defendant which was annexed. That letter was in all respects similar to the notice which was signed on behalf of the plaintiff on 2nd March, 1976 and

"In the event of the Borrower's liability to the Bank in respect of the principal not being totally discharged and satisfied on or before 31st March, 1978 (hereinafter called 'the expiration date') Beneficial will at the expiration of ninety (90) days notice in writing given to it by a duly authorised officer of the Bank, forthwith pay to the Bank the whole of the principal then owing together with all bank interest on the principal and all bank charges of and incidental thereto, owing to the Bank by the Borrower as at the date of payment, or otherwise make such arrangements to repay the Bank as are satisfactory to the Bank to fully discharge the liability of the Borrower to the Bank under the loan at the expiration of the said ninety (90) days notice PROVIDED HOWEVER that upon Beneficial complying with the terms of this letter of take-out, the Bank will at the expense of the Borrower transfer and assign its interest in the Bank's securities (as described in the original take-out letter and subject to paragraph 3 of the original take-out letter) to Beneficial in a manner and form satisfactory to Beneficial and its Solicitors AND PROVIDED FURTHER that the Bank shall not have hitherto and shall not pending the expiration date have done or omitted to do any act matter or thing (whether in the way of exercising or omitting to exercise any of the powers conferred on the Bank by the Bank's said securities or otherwise) as a result of which act or omission the value or the effectiveness of the Bank's securities shall have been in any way diminished or impaired (save in the manner contemplated by paragraph 3 of the original take-out letter)."

It is not material to refer to par.3. Paragraph 2 provided for the limitation of the plaintiff's liability to the sum of \$1,450,000 which was made up as provided for in pars. (a), (b) and (c) of the clause. A proviso to the paragraph required the plaintiff also to pay interest and certain other charges which were therein specified. Paragraphs 4, 5 and 6 of the notice were as follows:

"4. BENEFICIAL'S liability hereunder is conditional upon the Bank procuring the due payment by the Borrower or itself paying firstly the arrears of the commitment

- 5. BENEFICIAL hereby acknowledges that up to the date hereof there has been no breach by the Bank of any terms or conditions of the original take-out letter and that if there has been any such breach or breaches then such breach or breaches have been waived by Beneficial.
- THE Bank undertakes and agrees that if at any time after the date hereof the Bank becomes aware that the Borrower has defaulted in the due performance or observance of any covenant obligation or agreement on the part of the Borrower contained or implied in any one or more of the Bank's securities entitling the Bank to exercise its powers of entry into possession sale foreclosure or otherwise under the Bank's securities then and in any such event the Bank shall forthwith give notice in writing to Beneficial specifying the default which has occurred and at any time thereafter Beneficial may in its absolute and uncontrolled discretion elect to pay to the Bank forthwith (notwithstanding the provisions of paragraph 1 hereof) the principal and all other moneys owing by the Borrower to the Bank (as hereinbefore specified) as at the date of payment whereupon the Bank will at the expense of the Borrower transfer and assign its interest in the Bank's securities to Beneficial in a manner and form satisfactory to Beneficial and its Solicitors."

The Plaintiff relies on four grounds as providing reasons why it is not liable to indemnify the defendant. Each of these matters is an alleged failure on the part of the defendant either to comply with what is said to be a condition precedent to the plaintiff's liability or of an event to take place said to be a prerequisite to the plaintiff being liable. The acceptance of any one of the four submissions which were made would be sufficient to entitle the plaintiff to succeed.

I am clearly of opinion that its submissions in respect of two of the matters relied upon should be rejected. The first of these was based upon Cl. 6 of the notice of 2nd March, 1976 which obliged the defendant to notify the plaintiff of any default made by Tacking Point Downs in the due performance or observance of any covenant, obligation or agreement on its part contained or implied in any one or more of the defendant's securities. The breaches alleged were failures on the part of Tacking Point Downs to provide at the intervals provided for in cl.15 of an equitable mortgage, an audited balance sheet and trading and profit and loss accounts and to pay interest upon moneys secured by certain mortgages of real property. There was a submission on behalf of the defendant that there had been no failure on the part of Tacking Point Downs to pay interest, but in the view that I take of the matter it is unnecessary to decide that question. For the purposes of reaching a decision I assume that Tacking Point Downs was in breach of both provisions. consequence of a breach is provided for in cl.6 of the notice of 2nd March, 1976 which I have earlier set out. The consequence is that the plaintiff may in its absolute and uncontrolled discretion elect to pay to the Bank forthwith the principal and all other moneys owing by Tacking Point Downs to the defendant in return for an assignment of the defendant's securities. On no basis could it be said that the failure of the defendant to notify the plaintiff of a breach by Tacking Point Downs of its obligations was a condition precedent to the plaintiff's liability. At the most it would be entitled to maintain an action for damages, such damages being the loss suffered by the plaintiff as a result of being deprived of the opportunity to make the election provided for in cl.6.

The second matter relied upon, which in my opinion plainly cannot entitle the plaintiff to succeed, was an alleged breach of par. 2 of the take-out letter of 4th April, 1974 as subsequently The effect of that provision was that the defendant was not to be entitled to make any further advances to Tacking Point Downs "in respect of the loan" without the plaintiff's prior approval in writing, nor was the defendant entitled to charge up to that company's loan account any interest on the loan. For the purposes of the submission I assume that the evidence has established breaches of these provisions. Nevertheless the plaintiff's argument, in my opinion, fails because the breaches are not of provisions which are conditions precedent to the plaintiff's liability.

More substantial questions arise in relation to the other two matters relied upon by the plaintiff. The first of these is failure on the part of the defendant to see to it that the provisions of par. 4 of the notice of 2nd March, 1976 were complied with. In particular there were arrears of the commitment fee outstanding when the plaintiff's liability was said to have arisen on 31st March, 1978. It was the defendant's submission that there was no breach of the clause by it and that it was sufficient if it tendered the amount outstanding prior to making its claim to be indemnified. It did tender a bank cheque for what was agreed to have been the amount outstanding in respect of the commitment fee as at 31st March 1978 but the tender was rejected.

The material words of par. 4 of the notice of 2nd March, 1976 are as follows:

"BENEFICIAL'S liability hereunder is conditional upon the Bank procuring the due payment by the Borrower or itself paying ... all future commitment fees payable by the Borrower to Beneficial under the terms of the said Agreement (being at the rate of 3% per annum payable quarterly in advance)".

An analysis of the competing submissions made by the parties discloses that the difference between them lies in their respective contentions as to the category of case which this is. The plaintiff relied upon authorities that insist upon strict compliance with conditions found in agreements for the exercise of an option or some similar right. In Weston v. Collins (1865) 34 L.J. Ch. 353 at pp.354-5) Westbury, L.C. said:-

"The covenant by the defendant, on which this suit is founded, is so worded as to impose on the lessee ... the obligation of doing certain things as precedent conditions to any obligation arising on the part of the lessor. If the lessee chooses to comply with the conditions the lessor is bound, but previously there is no mutuality of contract; for whilst the lessor is bound to accept the requisition of the lessee if the conditions are fulfilled, there is no obligation on the part of the lessee to fulfill them, or to avail himself of the lessor's engagement. It is in fact a conditional offer by the lessor, and the condition must be observed before the offer becomes binding. It is a mistake to apply to a stipulation of this kind the rules which are applicable in this Court to ordinary contracts for the sale of real estate. In ordinary contracts of purchase both parties are at once bound, and

unless there be some special stipulation, No. 9 or some peculiar circumstances, the time for payment of the purchase-money or for conveyance of the estate, is not deemed of the essence of the contract; here, from the very form of the stipulation certain things must be done before a binding agreement can arise. If it be clear that any particular act is a condition precedent, it is immaterial whether it be or be not reasonable to require that it shall be first done on the one side before any obligation arises on the other ... Passing to the construction of the unilateral covenant before me, I think it clear that the delivery of the notice and payment of the purchase-money in the manner prescribed by the covenant are precedent conditions to be fulfilled by the owner of the lease before any contract arises binding the lessor."

The distinction referred to by Lord Westbury in Weston v. Collins between the two classes of contract was more recently referred to by Diplock, L.J. (as Lord Diplock then was) in United Dominions Trust (Commercial) Limited v. Eagle Aircraft Services <u>Limited</u> (1968) 1 W.L.R. 74 at pp.82-3. His Lordship said:

> "In Hongkong Fir Shipping Co. Ltd. v. Kawaski Kisen Kaisha Ltd. (1962) 2 Q.B. 26 a decision of this court upon which the judge relied, I was careful to restrict my own observations to synallagmatic contracts. insertion of this qualifying adjective was widely thought to be a typical example of gratuitous philological exhibitionism; but the present appeal does turn upon the difference in legal character between contracts which are synallagmatic (a term which I prefer to bilateral, for there may be more than two parties), and contracts which are not synallagmatic but only unilateral, an expression which, like synallagmatic, I have borrowed from French law (Code Civile Articles 1102 and 1103). Under contracts of the former kind each party undertakes to the other party to do or to refrain from doing something, and in the event of his failure to perform his undertaking, the law provides the other party with a remedy. The remedy of the other party may be limited to recovering monetary compensation for any loss which he has sustained as a result of the failure, without relieving him from his own obligation to do that which he himself has undertaken to do and has not yet done or to continue to refrain from doing that which he himself has undertaken

to refrain from doing. Or it may, in addition, entitle him, if he so elects, to be released from any further obligation to do or to refrain from doing anything. Hong Kong Fir case was concerned with the principles applicable in determing what kind of failure by one party to a synallagmatic contract to perform his undertaking releases the other party from an obligation, which ex hypothesi has already come into existence, to 10 continue to perform the undertaking given by him in the contract. The mutual obligations of parties to a synallagmatic contract may be subject to conditions precedent, that is to say, they may not arise until a described event has occurred; but the event must not be one which one party can prevent from occurring, for if it is, it leaves that party free to decide whether or not he will enter into any 20 obligations to the other party at all. The obligations under the contract lack that mutuality which is an essential characteristic of a synallagmatic contract."

Does the obligation here arise out of a unilateral contract, using that expression in the sense used by Lord Westbury and Lord Diplock, or is the obligation to be found in a contract which is bilateral or, to use Lord Diplock's words, a synallagmatic contract?

In my opinion the better view is that the obligation is to be found in a bilateral contract with the result that the option cases relied upon by the plaintiff have no application. I have reached this conclusion because the parties, prior to the notice of 2nd March, 1976 being sent, were already in contract. Already there were mutual rights and obligations in existence between them which had arisen out of the earlier documents of 4th April, 1974 and 1st May, 1974. It was the plain intention of the parties that the existing arrangement between them should continue but be varied as provided for in the notice of 2nd March, Although par. 4 of the notice was expressed as a condition of the plaintiff's liability under the original letter, it must be read in the context of a situation in which there were existing mutual rights and obligations between the parties and of a situation in which that would continue to be the In a case where an option is conferred upon one party to purchase the property of the other, whether in an option agreement dealing only with that matter, or in a lease, the situation is quite different. There may be existing rights and obligations between the parties in relation to the lease itself but there are no such continuing rights and obligations in relation to the matter of the

option. They will only arise if the party having the benefit of the option exercises it. In order that he may exercise it he must comply with the conditions to which its exercise is subject. If he does not comply with those conditions, any purported exercise of it will be no exercise at all.

Accordingly, I put the option cases aside. But, notwithstanding the dichotomy of the submissions of the parties, that is not the end of the matter. As always, the determining consideration is the intention of the parties as gleaned from the words they have used in the contractual documents.

There can be no question but that the payment of the commitment fee was, from the plaintiff's point of view, an all-important obligation imposed on the defendant and upon Tacking Point Downs. It was the entirety of the consideration to be received by the plaintiff for exposing itself to the very substantial liability it agreed to undertake. It would appear that the commitment fee had been in arrears prior to the giving of the notice of 2nd March, 1976. The purpose of par. 4 was to see to it that arrears were brought up to date (no question here arises as to that part of the paragraph) and that further instalments of the commitment fee would be paid. The defendant undertook an obligation to see that this occurred, it previously having been the obligation of Tacking Point Downs and not that of the defendant at all.

The obligation imposed by par. 4 was thus of the utmost importance. Nevertheless, it was an obligation requiring the defendant and Tacking Point Downs to make the payments within a specified time. It was accordingly an obligation as to time to which s.13 of the Conveyancing Act, 1919 applied. It is said in Chitty on Contracts (24th ed., vol. 1, par. 1271) that there are only three cases where time will be regarded as being of the essence of the contract. Those cases are:

- (a) Where the parties have expressly stipulated in their contract that the time fixed for performance must be exactly complied with;
- (b) Where the circumstances of the contract or the nature of the subject matter indicate that the fixed date must be exactly complied with;
- (c) Where time was not originally of the essence of the contract but one party has been guilty

of undue delay, the other party may give notice requiring the contract to be performed within a reasonable time.

Neither the circumstances mentioned in par.

(a) or par. (c) have any application here. There may have been a question as to whether the obligation to pay the arrears of \$10,000 was peremptory as to time. But notwithstanding the use of the expression "due payment" in the second line of the paragraph, I do not think that there is any basis for saying that the obligation as to payment of future commitment fees was of the essence of the contract, at least insofar as the express words of the parties are concerned.

The question is whether the case falls within the class of case referred to by Chitty in par.(b). The strength of the plaintiff's case lies in the use in the relevant paragraph of the notice of the words, "Beneficial's liability hereunder is conditional upon the Bank procuring \dots " On the other hand, if the plaintiff be right, the situation would be, as counsel for the defendant submitted, one in which there would be no liability on the part of the plaintiff under the letter if the fee were paid a week or even a day late. Having reflected on the matter, I do not think that the case does fall within par.(b) of Chitty. If the fee were paid repeatedly late, it would be open to the plaintiff to have given the defendant and Tacking Point Downs notice to pay within a reasonable time, and I suppose if the breach were continuous and often repeated, one might reach a stage where one would be inclined to say that the defendant and Tacking Point Downs had repudiated their obligations under the contract, evincing an intention no longer to be bound thereby. repudiation could have been accepted by the plaintiff and the contract discharged. But none of those events has happened. Accordingly, the failure of the defendant to see to it that the commitment fee was paid on time does not provide a reason why the plaintiff is not liable under its letter.

I turn to the final matter relied upon by the plaintiff. At the date of the letter of 4th April, 1974 there was, notwithstanding the provisions of recital B and of the first proviso to par. 1, no floating charge over the assets and undertaking of Tacking Point Downs. Such a floating charge was, however, executed by that company in favour of the defendant on 23rd December, 1975, that is prior to the notice of 2nd March, 1976 which varied the original letter. There is no evidence that the plaintiff was aware of the fact that there was no charge when it signed

the letter of 4th April, 1974, nor that it became aware of the existence of the charge executed in 1975 between that time and its signing of the notice on 2nd March, 1976. I should therefore approach the matter upon the basis that the plaintiff was at all times unaware that the charge referred to in the original letter did not then exist and upon the basis that when it came to sign the notice of 2nd March, 1976 it was under the impression that the charge had existed since before the original letter of 4th April, 1974. Counsel for the plaintiff submitted that that was the way in which the matter should be approached; counsel for the defendant did not submit otherwise.

The plaintiff submitted that it had promised to guarantee a liability described in the letter of 4th April, 1974 as a liability secured by "a floating debenture charge over the assets and undertakings" of Tacking Point Downs. Since at the date of the letter the liability was not so secured, there was no liability such as was described in the letter. The plaintiff placed reliance upon the decision of the House of Lords in Greer v. Kettle (1938) A.C. 156. In that case a guarantee recited that a lender had, at the request of another company, advanced to the borrower a sum of \$250,000 "on the security of a charge dated March 20, 1929 on the shares particulars of which are set out in the schedule hereto". The operative part of the guarantee was:

"In consideration of the corporation having at the request of the guarantors advanced to the borrowers the said sum of \$250,000, the guarantors hereby covenant with the corporation that in the event of the borrowers failing to repay the said sum of \$250,000 and interest as provided in the said charge on June 20 next forthwith to repay to the corporation the said sum of \$250,000 together with all interest due ..."

It was held by the House of Lords that what the guarantors agreed to guarantee was the repayment of a debt effectively secured by shares in a company, and as in fact the debt was not so secured, the guarantors were under no liability; nor were they estopped by the terms of the recital in the guarantee.

Apart from submitting that the case was distinguishable from Greer v. Kettle because the loan here was not by description a loan secured by a floating charge over the assets and undertaking of Tacking Point Downs, the defendant submitted that the provisions of par. 5 of the notice of 2nd March,

1976, could have no application because it was concerned with breaches of terms and conditions of the original letter; the plaintiff was not relying on a breach of any term or condition, but upon the fundamental point that, if the defendant were entitled to an indemnity, it was an indemnity against a liability which was secured in the manner described in the relevant recital. True it had undertaken to the defendant that it would pay the indebtedness of Tacking Point Downs to it if the events provided for in the letter came about. But the indebtedness or liability was, upon the true construction of the letter, a liability secured in the way described in the recital. It was not, at the date of the letter, secured to the extent therein stated. The plaintiff's premise did not therefore extend to Thus no question of any breach by the it. defendant of a term or condition of the agreement arose. Paragraph 5 of the notice of 2nd March, 1976, dealing, as it did, with the waiver of breaches of terms and conditions had no application. On the contrary, it was a case where, there being no equitable charge in existence at the date of the original letter, no liability of the kind promised to be assumed had ever existed. In my opinion the plaintiff's submission is correct. The paragraph is not, if the plaintiff's construction of the letter is right, of any assistance to the defendant. In this respect I compare, although it is a case in a different field of the law of contract, the decision of the High Court in George Wills & Co. Limited v. Davids Pty. Limited, 98 C.L.R. 77.

I turn next to the question of construction which is involved. In order to test the matter, I propose to assume that neither the mortgages referred to in recital B and the first proviso to par. 1 of the original letter, any more than the equitable charge, were in existence at the date of that letter. If that had been the position, the debt would in fact have been an unsecured one. that event ought the position be regarded as one in which the parties intended that the liability should nevertheless be assumed by the plaintiff, it having the right to claim damages for breach of an implied promise on the defendant's part that the indebtedness was secured in the way provided for; or do the words of the parties mean that they intended that it was only a liability which was secured as provided for in the original letter which the plaintiff was to undertake? The question being one of construction, the decision of the House of Lords in Greer v. Kettle is not decisive unless the wording of the agreement in that case is indistinguishable from that in the present one. I think there are differences in the wording.

as in this case, the reference to the indebtedness being secured was in a recital and not in the operative part of the guarantee. I am therefore of opinion that, although Greer v. Kettle is distinguishable, it has similarities to the present case and provides some guide as to what the outcome should be. Apart from that consideration, I think that the better view is that the proper construction of the letter is, as the plaintiff submits, that the parties intended that there should be guaranteed only a liability which was secured as stated therein. In order to throw up the problem I made the assumption that the indebtedness was totally unsecured. In fact it was secured by the mortgages which are referred to but not by the floating charge. But it was not secured to the extent that the parties contemplated it would be, and I am thus of opinion that the plaintiff is entitled to succeed on this point.

The defendant submitted that it did not matter when the charge was taken. The important consideration was that it should have existed at the time when the plaintiff was called upon to pay the amount of the liability of Tacking Point Downs under the guarantee. I do not agree with this submission. The securities referred to in the letter of 4th April, 1974 (including the equitable charge) were, notwithstanding the variation of the agreement which was brought about by the plaintiff's notice of 2nd March, 1976, at all times intended by the parties to be the securities of which the plaintiff would have the benefit if it were called upon to indemnify the I refer to the terms of the first defendant. proviso of par. 1 of the notice of 2nd March, 1976. If it came to a contest, there might be a nice question as to whether the parties could be said to have intended that the equitable charge which was taken on 23rd December, 1975, was picked up by the words used in that proviso. And, in the event of there being an earlier charge by the plaintiff, the acceptance of the submission that the position was cured by the taking of the charge on 23rd December, 1975, would mean that the plaintiff would have to be satisfied by the provision of a security which might be later in point of time to an earlier charge granted to some other person. The fact that there is no evidence or suggestion that there is any earlier charge is not to the point. It is a question of determining the intention of the parties by reference to the words they have used and to events which might, in their reasonable contemplation, well have occurred. The agreement as varied provided for the guarantee by the

Mr. Justice Sheppard 22nd June 1979 (cont'd) plaintiff of a liability which was secured, inter alia, by a floating charge which was in existence at the date of the original letter. There was no such floating charge. Accordingly, no liability of a kind which the plaintiff promised to guarantee ever existed.

My conclusion upon the final matter which I have dealt with means that the plaintiff is entitled to the relief which it seeks and that the defendant fails in its cross-claim. The only cross-claim brought by the defendant was for the recovery of the amount said to be due to be paid by the plaintiff in the event that it was obliged to indemnify the defendant under the letter. I have given no consideration as to whether the defendant is entitled to recover from the plaintiff any payments which may have been made by it in respect of the commitment fee, the plaintiff never having been, in my opinion, liable under the letter at all.

I propose to stand this matter over for a short time to enable counsel to consider what I have said. When it is again in the list, counsel for the plaintiff are to bring in short minutes of a declaration to give effect to my decision. My conclusion makes it unnecessary for there to be quantified the amount which the defendant would have been entitled to recover if it had been successful, but if it be desired for any reason to have that sum quantified, I am prepared, when the matter is again in the list, to note any agreement about it or to hear evidence concerning it with a view to making a finding, if that is what the parties wish.

The Bank has provided or agreed to provide additional loans commercial bills and other banking accommodation to the Borrower up to a maximum amount (including the original advance) of \$1.45 Million (hereinafter called "the principal") (subject to Beneficial extending the terms of the original take-out letter to cover the said principal).
- F. The parties hereto have agreed to vary certain terms and conditions referred to in the loagreements dated 4th April 1974 and 1st May 1974 in the manner hereinafter set forth.

NOW IT IS HEREBY AGREED as follows:-

- 2. SUBJECT to the proviso hereto contained Beneficial's liability hereunder is limited to the sum of \$1.45 Million which comprises:-
- (a) The Bank's liability as endorser under the Commercial Bill Non-Discount Acceptance Line of \$1 Million;

- (b) The Bank's liability under an indemnity/ guarantee provided or to be provided by the Bank to the Port Macquarie Municipal Council on behalf of the Borrower in the sum of \$250,000.00; and
- (c) Overdraft facilities up to \$200,000.00 to be extended by the Bank to the Borrower to meet development expenses on the Borrower's Port Macquarie lands, all drawings on which must be countersigned by a nominee of Beneficial.

PROVIDED HOWEVER that notwithstanding anything hereinbefore contained or contained in the original letter of take-out Beneficial shall in addition to repaying the principal, pay to the Bank interest on the said principal and all other charges normally made by the Bank up to the date of discharge of its securities including but not limited to the following, namely all holding charges, rates, land tax, take-out fees, endorsement fees and indemnity guarantee fees.

- 3. THE liability of Beneficial under paragraph linereof includes and is not in addition to its liability under the original take-out letter, the terms of which shall continue to apply save as herein varied.

BENEFICIAL'S liability hereunder is conditional upon the Bank procuring the due payment by the Borrower or itself paying firstly the arrears of the commitment fees totalling \$10,000.00 owing by the Borrower under the Agreement of 4th April 1974 between (inter alia) Beneficial and the Borrower such payment to be made not later than 4th April 1976 and secondly all future commitment fees payable by the Borrower to Beneficial under the terms of the said Agreement (being at the rate of 3% per annum payable quarterly in advance).
- 5. BENEFICIAL hereby acknowledges that up to the date hereof there has been no breach by the Bank of any terms or conditions of the original take-out letter and that if there has been any such breach or breaches then such breach or breaches have been waived by Beneficial.

We acknowledge receipt of your letter of the 19th December, 1977.

The terms of the letter and the circumstances leading to its despatch have caused us to critically examine our position. Accordingly, we must point out that there has occurred nonfulfilment with the condition contained in Clause 4 of the Undertaking of 2 March 1976 and that accordingly, our liability under Clause 1 to "takeout" cannot and will not be accepted on our part. The non-fulfilment comprises at least the nonpayment of the last commitment fee to fall due and payable under the terms of the relevant Agreement with the Borrower on 4 January, 1978.

In addition to Clause 4, there has occurred non-fulfilment of the following further contractual conditions:

- (i) That contained in Clause 6 of the 2 March 1976 Undertaking, relating to the giving to us of notice specifying defaults. You would doubtless be aware of all relevant defaults. No notice thereof has ever been given to us.
- (ii) That contained in Clause 2 of the letter of undertaking dated 4 April 1974, as preserved by Clause 3 of the 2 March 1976 Undertaking, relating to the making of further advances without our consent. Again, you would doubtless have full details of such advances.
- (iii) That contained in the second proviso to Clause 1 of the 2 March 1976 Undertaking

relating to acts or omissions diminishing or impairing the value or effectiveness of the Bank's securities.

Additionally, contrary to Recital B contained in the letter of 4 April 1974, no floating debenture charge over the assets and undertakings of the Borrower then existed, nor was in fact obtained until 23 December 1975; both of the undertakings referred to in this letter were predicated, whether expressly or by implication, on the charge having been in existence on or before 4 April 1974 and upon such charge being ultimately available for transfer contemporaneously with "take-out".

For the foregoing and any other grounds which may be presently available to us, we repeat that we must decline liability to "take-out" under Clause 1 of the 2 March 1976 Undertaking. In case you dispute our entitlement to so decline liability, we have instructed our solicitors to prepare a Summons for declaratory relief so that any such dispute can be conveniently determined by the Supreme Court as early as possible. Could you please let us know your views on the matter within the next ten days.

- l. With regard to your statement that the last commitment fee due on 4th January, 1978 has not been paid it is noted that you did not inform the Bank of this before your letter of the 7th instant, and further, that as your Company is required under account authority to countersign all cheques of 20 Tacking Point Downs Pty Limited your Company had adequate means of seeing that payment was made at the correct time or of informing the Bank if it was not. Pursuant to Clause 4 of the amending Agreement of 2nd March 1976 we have endeavoured to arrange issue of a cheque to cover the amount of the Commitment Fee to 4/1/78 but our efforts have been thwarted by your refusal to allow issue of a cheque form from the book which is held by you and in terms of the Bank Authority we 30 are aware that such cheques are to be countersigned by officers of your Company.
- 2. With regard to the giving to your Company under Clause 6 of the amending Agreement of 2nd March 1976 notice of defaults under the securities held by the Bank, we would enquire what defaults your Company alleges have occurred. The Bank, not having had notice of any defaults under the securities, has not been required to give any notice of defaults to your Company.
- 3. With regard to the suggestion that the Bank has made further advances to Tacking Point Downs Pty Limited without your Company's consent, this is emphatically denied. Your Company has at all times been aware of increases granted and its representatives in fact have been involved with the interviews held with the Bank to arrange increases. Your Company's representative actually signed acknowledgement and confirmation of the last arrangement for increase contained in the Bank's letter to your Company of 10th August 1977.

4. With regard to the suggestion that the Bank has by its acts or omissions impaired the value or effectiveness of the Bank's securities, this is also emphatically denied. We would suggest that you specify such acts and omissions of the Bank as your Company alleges have occurred and have had the effect above mentioned.
