

SO IF U ARE REALTY EEE REALLY INTERESTED IN CO - OPERATING WITH US U HAVE TO CHANGE YOUR WAY OF DOING BUSINESS. IF IN THIS CASE U ARE EEE FIND THAT IT IS NOT TO YOUR BENEFIT TO COVER HCC U SHOULD AT LEAST GIVE US AN EXPLANATION BEFORE WE CONFIRMED WITH NOL AND NOT AFTER. NOW I FEEL THAT U ON YOUR PART ALSO HAS NO SYSTEM IN DOING BUSINESS AS I FIND THAT U CHANGE YOUR WORDS TO SUIT YOURSELF. THIS IS NOT OUR STYLE OF DOING BUSINESS. I FEEL THAT U MUST GIVE HE A REPLY TODAY TO CLEAR THE AIR ON THIS MATTER.







1 After 4 months of personnal experience, as delegate to control Inter's consignation stock and sales program for the Far East and South East Asia, I have noticed myself that my presence and my information has never been precise nor complete to comply properly with my job.

- 2 I was very disappointed when I noticed that, although against the agreement between Hock Cheong & Co and Inter, Jurong office for Hock Cheong & Co was under-cutting the work of Kallang office.
- 3 For several times Hock Cheong & Co has tried to produce the same equipment as Inter without their consent.
- 4 After following the discussions between major shareholders, certain restrictions have been done to my housing expenses and personnal capability for employing the staff whom I may consider the best.




