An Act for the more effectual Prevention of Persons going armed by Night for the Destruc-[19th July 1828.] tion of Game.

HEREAS an Act was passed in the Fifty-seventh Year of the Reign of His late Majesty King George the Third, intituled An Act for Prevention of Persons going armed 57 G.3. c.90. by Night for the Destruction of Game; and for repealing an Act made in the last Session of Parliament, relating to Rogues and Vagabonds: And whereas the Practice of going out by Night for the Purpose of destroying Game has nevertheless very much increased of late Years, and has in very many Instances led to the Commission of Murder, and of other grievous Offences; and it is expedient to repeal the said recited Act, and to make more effectual Provisions than now by Law exist for repressing such Practice: May it please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That the said recited Act shall Recited Act be and the same is hereby repealed, except so far as the same repeals repealed. any other Acts; and if any Person shall, after the passing of this Act, Persons by Night, unlawfully take or destroy any Game or Rabbits in any taking or Land, whether open or inclosed, or shall by Night unlawfully enter Game by or be in any Land, whether open or inclosed, with any Gun, Net, Night to be Engine, or other Instrument, for the Purpose of taking or destroying committed, Game, such Offender shall, upon Conviction thereof before Two for the 1st Justices of the Peace, be committed for the First Offence to the 3 Months, Common Gaol or House of Correction for any Period not exceeding and kept to Three Calendar Months, there to be kept to hard Labour, and at the hard Labour, Expiration of such Period shall find Sureties by Recognizance, or in Sureties. Scotland by Bond of Caution, himself in Ten Pounds, and Two Sureties in Five Pounds each, or One Surety in Ten Pounds, for his not so offending again for the Space of One Year next following; and in case of not finding such Sureties, shall be further imprisoned and kept to hard Labour for the Space of Six Calendar Months, unless 2d Offence, such Sureties are sooner found; and in case such Person shall so 6 Months, and kept to hard Labour, and shall be thereof convicted before Two hard Labour, Justices of the Peace, he shall be committed to the Common Gaol and to find

or Sureties;

or House of Correction for any Period not exceeding Six Calendar Months, there to be kept to hard Labour, and at the Expiration of such Period shall find Sureties by Recognizance, or Bond as aforesaid, himself in Twenty Pounds, and Two Sureties in Ten Pounds each, or One Surety in Twenty Pounds, for his not so offending again for the Space of Two Years next following; and in case of not finding such Sureties, shall be further imprisoned and kept to hard Labour for the Space of One Year, unless such Sureties are sooner found; and in case such Person shall so offend a Third Time, he shall be guilty of a Misdemeanor, and being convicted thereof, shall be liable. at the Discretion of the Court, to be transported beyond Seas for Seven Years, or to be imprisoned and kept to hard Labour in the Common Gaol or House of Correction for any Term not exceeding Two Years; and in Scotland, if any Person shall so offend a First, Second, or Third Time, he shall be liable to be punished in like Manner as is hereby provided in each Case. II. And be it enacted, That where any Person shall be found

upon any Land committing any such Offence as is herein-before men-

tioned, it shall be lawful for the Owner or Occupier of such Land.

or for any Person having a Right or reputed Right of Free Warren

or Free Chase thereon, or for the Lord of the Manor or reputed

Manor wherein such Land may be situate, and also for any Game-

keeper or Servant of any of the Persons herein mentioned, or any Person assisting such Gamekeeper or Servant, to seize and apprehend such Offender upon such Land, or in case of Pursuit being made, in any other Place to which he may have escaped therefrom, and to deliver him, as soon as may be, into the Custody of a Peace Officer,

Owners or Occupiers of Land, Lords of Manors. or their Servants, may apprehend Offenders.

in order to his being conveyed before Two Justices of the Peace; and in case such Offender shall assault or offer any Violence with Offenders any Gun, Crossbow, Fire Arms, Bludgeon, Stick, Club, or any other offensive Weapon whatsoever, towards any Person hereby authorized to seize and apprehend him, he shall, whether it be his First, assaulting or offering Violence deemed guilty of Mis-Second, or any other Offence, be guilty of a Misdemeanor, and being demeanor, be transported beyond Seas for Seven Years, or to be imprisoned and kept to hard Labour in the Common Gaol or House of Correction Years, or for any Term not exceeding Two Years; and in Scotland, whenever imprisoned any Person shall so offend, he shall be liable to be punished in like

and liable to be transported for Seven for 2 Years.

III. And be it further enacted, That where any Person shall be charged on the Oath of a credible Witness, or in Scotland on the Application of the Procurator Fiscal of Court, before any Justice of the Peace, with any Offence punishable upon summary Conviction by virtue of this Act, the Justice may issue his Warrant for apprehending such Person, and bringing him before Two Justices of the Peace, to be dealt with according to Law.

Limitation of Time for Proceedings under this Act.

IV. And be it enacted, That the Prosecution for every Offence punishable upon summary Conviction by virtue of this Act shall be commenced within Six Calendar Months after the Commission of the Offence; and the Prosecution for every Offence punishable upon Indictment, or otherwise than upon summary Conviction, by virtue of this Act, shall be commenced within Twelve Calendar Months after the Commission of such Offence.

V. And be it enacted, That the Justices of the Peace before whom Form of any Person shall be summarily convicted of any Offence against this Act may cause the Conviction to be drawn up in the following Form of Words, or in any other Form of Words to the same Effect, as the Case may require; that is to say,

VI. And be it further enacted, That any Person who shall think Appeal. himself aggrieved by any such summary Conviction may appeal to the next Court of General or Quarter Sessions which shall be holden, not less than Twelve Days after the Day of such Conviction, for the County, Riding, or Division wherein the Cause of Complaint shall have arisen; provided that such Person shall give to the Complainant a Notice in Writing of such Appeal, and of the Cause and Matter thereof, within Three Days after such Conviction, and Seven clear Days at the least before such Sessions, and shall also either remain in Custody until the Sessions, or within such Three Days enter into a Recognizance, or Bond of Caution in Scotland, with a sufficient Surety, before a Justice of the Peace, conditioned personally to appear at the said Sessions, and to try such Appeal, and to abide the Judgment of the Court thereupon, and to pay such Costs as shall be awarded by the Court; and upon such Notice being given, and such Recognizance or Bond being entered into, the Justice before whom the same shall be entered into shall liberate such Person if in Custody; and the Court at such Sessions shall hear and determine the Matter of the Appeal, and shall make such Order therein, with or without Costs to either Party, as to the Court shall seem meet; and in case of the Dismissal of the Appeal, or the Affirmance of the Conviction, shall order and adjudge the Offender to be dealt with and punished according to the Conviction, and to pay such Costs as shall be awarded; and shall, if necessary, issue Process for enforcing such Judgment.

VII. And be it further enacted, That no such Conviction, or No Cer-Adjudication made on Appeal therefrom, shall be quashed for Want tiorari, &c. of Form, or be removed by Certiorari, or otherwise, into any of His Majesty's Superior Courts of Record, or in Scotland by Advocation

or Suspension into any Superior Court; and no Warrant of Commitment shall be held void by reason of any Defect therein, provided it be therein alleged that the Party has been convicted, and there be a good and valid Conviction to sustain the same.

Convictions to the Quarter Sessions and registered, and may be given in Evidence.

VIII. And be it enacted, That on every Conviction under this Act tobereturned for a First or Second Offence the convicting Justices shall return the same to the next Quarter Sessions for the County, Riding, Division, City, or Place wherein such Offence shall have been committed; and the Record of such Conviction, or any Copy thereof, shall be Evidence in any Prosecution to be instituted against the Party thereby convicted for a Second or Third Offence; and the Clerk of the Peace shall immediately on such Return make or cause to be made a Memorandum of such Conviction in a Register to be kept by him of the Names and Places of Abode of the Persons so convicted, and shall state whether such Conviction be the First or Second Conviction of the offending Party.

If Persons to the Number of Three, being armed, enter any Land for the Purpose of taking or destroying Game, &c. they shall be deemedguilty of a Misdemeanor.

IX. And be it enacted, That if any Persons, to the Number of Three or more together, shall by Night unlawfully enter or be in any Land, whether open or inclosed, for the Purpose of taking or destroying Game or Rabbits, any of such Persons being armed with any Gun, Crossbow, Fire Arms, Bludgeon, or any other offensive Weapon, each and every of such Persons shall be guilty of a Misdemeanor, and being convicted thereof before the Justices of Gaol Delivery, or of the Court of Great Sessions of the County or Place in which the Offence shall be committed, shall be liable, at the Discretion of the Court, to be transported beyond Seas for any Term not exceeding Fourteen Years nor less than Seven Years, or to be imprisoned and kept to hard Labour for any Term not exceeding Three Years; and in Scotland any Persons so offending shall be liable to be punished in like Manner.

Jurisdiction of Sheriffs in Scotland.

Convictions.

X. And be it enacted, That in Scotland the Sheriff of the County within which the Offence shall have been committed shall have a cumulative Jurisdiction with the Justices of the Peace in regard to the same; and the Conviction in Scotland may be proved in the same Manner as a Conviction in any other Case according to the Law of Scotland.

Third Offences, &c. to be tried

in certain

Courts.

XI. And be it enacted, That in all Cases in Scotland of a Third Offence, or in other Cases in Scotland where a Sentence of Transportation may, by the Provisions of this Act, be pronounced, the Offender shall be tried before the High Court or Circuit Court of Justiciary.

What Time shall be consideredNight.

XII. Provided always, and be it enacted, That for the Purposes of this Act the Night shall be considered and is hereby declared to commence at the Expiration of the first Hour after Sunset, and to conclude at the Beginning of the last Hour before Sunrise.

What shall be deemed Game.

XIII. And be it enacted, That for the Purposes of this Act the Word "Game" shall be deemed to include Hares, Pheasants, Partridges, Grouse, Heath or Moor Game, Black Game, and Bustards.
