ROAD TRAFFIC

The A35 Trunk Road (Raymond's Hill, Near Axminster) (Temporary Restriction of Traffic) Order 2010

Made - - - - 31 August 2010

Coming into force - - 4 September 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A35 Trunk Road ("the A35"), is satisfied that traffic on lengths of that road near Axminster in the District of East Devon in the County of Devon and the District of West Dorset in the County of Dorset should be restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A35 Trunk Road (Raymond's Hill, Near Axminster) (Temporary Restriction of Traffic) Order 2010 and shall come into force on 4 September 2010.

2. In this Order –

"the first length of the A35" means the A35 from a point 300 metres west of the centre of its junction with Green Lane, Raymond's Hill, to a point 100 metres west of its junction with Elsdon's Lane (at the start of the dual carriageway);

"the second length of the A35" means the A35 from a point 150 metres east of the centre of its junction with Green Lane, Raymond's Hill, to a point 100 metres west of its junction with Elsdon's Lane (at the start of the dual carriageway);

"the works" mean carriageway repairs and resurfacing works;

"the works period" means the period starting at 00.01 hours on Monday 6 September 2010 and ending when the said works have been completed;

"a works period" means a period of 10 hours starting at 20.00 hours on Monday 6 September 2010 or any other day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during a works period, drive any motor vehicle at a speed exceeding 10 miles per hour in the first length of the A35 whilst traffic signs of a character authorised under section 64 of the Road Traffic Regulation Act 1984 indicating "convoy working" on that road are displayed.

- **4.** Subject as mentioned in article 5, no person shall, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour in the second length of the A35.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) anything done at the direction of, or with the permission of, a constable.
