The M69 Motorway and The A5 Trunk Road (M69 Junction 1) (Temporary Prohibition of Traffic) Order 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the M69 Motorway ("the M69"), the A5 Trunk Road ("the A5") and connecting roads, is satisfied that traffic on a length of that trunk road and three of those connecting roads in the Counties of Warwickshire and Leicestershire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984 (a), and of all other powers enabling him in that behalf, hereby makes the following Order: -

1. This Order may be cited as the M69 Motorway and The A5 Trunk Road (M69 Junction 1) (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 13 September 2010.

2. In this Order:

| "the trunk road" | means the circulatory carriageway of the A5 between its junction with the slip road leading to the northbound carriageway of the M69 and its junction with the slip road leading from the southbound carriageway of the M69 (M69 Junction 1); |

| "a slip road" | means – (i)the slip roads leading to and from the southbound carriageway of the M69 at Junction 1; and |
| | (ii) the slip road leading to the northbound carriageway of the M69 at Junction 1; |
| "the works period" | means the period starting at 20.00 hours on Monday 20 September 2010 and ending when the said works have been completed; |

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the trunk road or a slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- (i) being used for police, fire brigade or ambulance purposes;
- (ii) proceeding at the direction of, or with the permission of, a police constable, or traffic officer in uniform, or
- (iii) being used in connection with the said works or by a traffic officer in uniform.
