## ROAD TRAFFIC

## The M1 Motorway (Junction 21a) (Temporary Restriction and Prohibition of Traffic) Order 2010

Made - - - - 20 September 2010

Coming into force - - 27 September 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the M1 Motorway ("the M1"), is satisfied that traffic on a length of that motorway in the County of Leicestershire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and (7) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order: -

**1.** This Order may be cited as the M1 Motorway (Junction 21a) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 27 September 2010.

## 2. In this Order:

"the motorway"

"the works period"

and a point 4200 metres north of the centre line of the Ratby Lane overbridge at Kirby Muxloe (M1 Junction 21a);

"the Regulations" means the Motorways Traffic (England and Wales) Regulations 1982(b);

"a hard shoulder" means the hard shoulder, within the meaning of regulation 3(1)(e) of the Regulations, which is adjacent to the motorway;

means the period starting at 2200 hours on Monday 4 October 2010 and ending when the said works have been

means the northbound carriageway and the southbound carriageway of the M1 between a point 2800 metres south

completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour on the motorway.
- **4.** Subject as mentioned in articles 5 and 6 no person shall, during the works period, cause or permit any vehicle to enter or proceed on the motorway.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - **6.** The provisions of
    - (a) articles 3 and 4 shall not apply to any vehicle
      - (i) being used for police, fire brigade or ambulance purposes; or
      - (ii) proceeding at the direction of, or with the permission of, a police constable; and
    - (b) article 4 shall not apply to any vehicle being used in connection with the said works or by a traffic officer in uniform.
- 7. During the works period, regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Regulations, in respect of a hard shoulder, are hereby suspended at such times and to such extent as may from time to time be indicated by traffic signs.
