The M62 Motorway Junction 10 (Westbound and Eastbound Link Roads to the M6 Northbound) (Temporary Prohibition of Traffic) (No 2) Order 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the M62 Motorway and link roads, is satisfied that traffic on two of those link roads, in the Borough of Warrington, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984 (a), hereby makes the following Order.

1. This Order may be cited as The M62 Motorway Junction 10 (Westbound and Eastbound Link Roads to the M6 Northbound) (Temporary Prohibition of Traffic) (No 2) Order 2010 and shall come into force on 10 October 2010.

2. In this Order:

"the motorway" means the M62 Motorway;

"the first link road" means the link road leading from the westbound carriageway of the motorway at Junction 10 to the M6 Motorway northbound carriageway;

"the second link road" means the link road leading from the eastbound carriageway of the motorway at Junction 10 to the M6 Motorway northbound carriageway;

"the works period" means periods over two nights between 2200 hours and 0500 hours during the following periods:

- i. starting on Monday 11 October 2010 and ending on Monday 18 October 2010; and
- ii. starting on Thursday 16 December 2010 and ending on Thursday 23 December 2010.

However, work may start and continue between the same times on subsequent nights or continue overnight until completed, for such further period not exceeding 18 months as shall be required to complete the work;

"Works" means the installation and removal of traffic management for safety barrier renewal works on the M6 Motorway.

3. Subject as mentioned in article 4 of this Order, during the works period, no person shall cause or permit any vehicle to enter or proceed in the first or second link roads.

4. The provisions of article 3 of this Order shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle being used in connection with the works or by traffic officers, or for emergency purposes by the police, fire and rescue or ambulance services, or proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform.
