ROAD TRAFFIC

The M1 and M6 Motorways and the A14 Trunk Road (M1 Junction 19 to A5199) (Temporary Prohibition of Traffic) (No. 2) Order 2010

Made - - - 8 November 2010

Coming into force - - 15 November 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the M1 Motorway ("the M1"), the M6 Motorway ("the M6"), the A14 Trunk Road ("the A14") and connecting roads, is satisfied that traffic on lengths of the A14 and four of those connecting roads in the Counties of Leicestershire and Northamptonshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the M1 and M6 Motorways and the A14 Trunk Road (M1 Junction 19 to A5199) (Temporary Prohibition of Traffic) (No. 2) Order 2010 and shall come into force on 15 November 2010.

2. In this Order –

"the trunk road" means –

- (i) the eastbound carriageway of the A14 from its junction with Swinford Road (west of M1 Junction 19) to its junction with the slip road leading from the A5199;
- (ii) the westbound carriageway of the A14 from its junction with the slip road leading to the A5199 to its junction with Swinford Road (west of M1 Junction 19)

"a slip road" means the slip roads leading –

(i) to the northbound carriageway of the M1 at Junction 19:

- (ii) from the southbound carriageway of the M1 at Junction 19;
- (iii) from the eastbound carriageway of the M6 to the A14 (M1 Junction 19); and
- (iv) to the westbound carriageway of the A14 from its junction with the A5199, Northampton Road;

"the works period"

means the period starting at 22:00 hours on Friday 19 November 2010 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.
- **4.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or leave the A14 at its junction with Rugby Road, east of M1 Junction 19.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable or traffic officer in uniform; or
 - (c) being used for or in connection with the said works or by a traffic officer in uniform.
