ROAD TRAFFIC

The A3 Trunk Road (Chalton Lane – Gravel Hill, Northbound Carriageway) (Temporary Prohibition of Traffic) Order 2010

Made - - - - 15th November 2010

Coming into force - - 4th December 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A3 Trunk Road, is satisfied that traffic should be prohibited on a length of that road because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A3 Trunk Road (Chalton Lane – Gravel Hill, Northbound Carriageway) (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 4th December 2010.

2. In this Order:

"the trunk road" means the A3 Trunk Road south of Petersfield in the County of Hampshire;

"the length of northbound carriageway" means the northbound carriageway of the trunk road between the slip road leading to Chalton Lane near Clanfield and the slip road leading to that carriageway at Gravel Hill;

"works" mean essential carriageway repairs, power cable repairs and all associated work on the trunk road; and

"a works period" means a period of –

- (i) 7½ hours starting at 2200 hours on Monday 6th December 2010 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2230 hours on Friday 10th December 2010 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 11th December 2010 or on any subsequent Saturday, or
- (iv) 7 hours starting at 2230 hours on Sunday 12th December 2010 or on any subsequent Sunday,

until 3rd June 2012.

3. Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the length of northbound carriageway.

- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
 - (a) a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
 - (d) any vehicle being used for winter maintenance purposes.
