## ROAD TRAFFIC

# The A50 Trunk Road (Meir Tunnel, Stoke-on-Trent) (Temporary Prohibition of Traffic) (No. 3) Order 2010

Made - - - 03 December 2010

Coming into force - - 10 December 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50"), is satisfied that traffic on lengths of that road at Meir in the City of Stoke-on-Trent should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) and of all other powers enabling him in that behalf, hereby makes the following Order: -

**1.** This Order may be cited as The A50 Trunk Road (Meir Tunnel, Stoke-On-Trent) (Temporary Prohibition of Traffic) (No. 3) Order 2010 and shall come into force on 10 December 2010.

#### 2. In this Order:

"the eastbound carriageway" means the eastbound carriageway of the A50 from a point 200 metres west of the entrance to Meir Tunnel to a point 420 metres east of the exit from Meir Tunnel; "the westbound carriageway" means the westbound carriageway of the A50 from a point 200 metres east of the entrance to Meir Tunnel to a point 170 metres west of the exit from Meir Tunnel;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- 3. Subject as mentioned in article 4, during the periods specified in the Schedule to this Order, no person shall cause or permit any vehicle to enter or proceed in the eastbound carriageway or the westbound carriageway.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to any vehicle -
  - (a) being used in connection with the said work;
  - (b) being used for police, fire brigade or ambulance purposes; or

(c) proceeding at the direction of, or with the permission of, a police constable.
