ROAD TRAFFIC

The A2 Trunk Road (Wick Lane – Coxhill) (Temporary Restriction and Prohibition of Traffic) Order 2010

Made - - - - 13th December 2010

Coming into force - - 4th January 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A2 Trunk Road, is satisfied that traffic should be restricted and prohibited on lengths of that road because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A2 Trunk Road (Wick Lane – Coxhill) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 4th January 2011.

2. In this Order:

"the trunk road" means the A2 Trunk Road near Dover in the County of Kent;

"the length of trunk road" means both carriageways of the trunk road between its junction with Wick Lane and a point 700 metres east of its junction with Coxhill;

"a side road" means -

- (i) Wootton Lane (Dumbrill Hill) at its junction with the Londonbound carriageway of the trunk road near Lydden International Motor Racing Circuit, or
- (ii) the road (Westcourt Road) leading to and from the coastbound carriageway of the trunk road towards Shepherdswell and Barfrestone;

"works" means gap closure work on the trunk road; and

- "the works period" means the period starting on Tuesday 4th January 2011 and ending on 3rd July 2012.
- **3.** Subject as mentioned in articles 5 and 6 below, no person shall, during the works period, cause or permit any vehicle to enter a side road from the trunk road or to enter the trunk road from a side road.
- **4.** Subject as mentioned in articles 5 and 6 below, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the length of trunk road.
- **5.** The provisions of articles 3 and 4 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs.
 - **6.** (1) Nothing in article 3 above shall apply to -
 - (a) a vehicle being used in connection with the said works;

- (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
- (2) Nothing in article 4 above shall apply to a vehicle being used for police, ambulance or fire and rescue authority purposes.
