ROAD TRAFFIC

The A421 Trunk Road (Brogborough, Bedfordshire) (Temporary Restriction and Prohibition of Traffic) Order 2010

Made - - - - 31 December 2010

Coming into force - - 7 January 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A421 Trunk Road ("the A421") is satisfied that traffic on that trunk road in the County of Bedfordshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order: -

- **1.** This Order may be cited as the A421 Trunk Road (Brogborough, Bedfordshire) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 7 January 2011.
 - 2. In this Order –

"the trunk road" means the A421 from its roundabout junction with the C94 Bedford Road, Brogborough to its roundabout junction with the C94 Bedford Road, Husborne Crawley, including the circulatory carriageway of those roundabouts;

"works" mean bridge parapet and edge beam replacement to the M1 overbridge at Juntion 13 and additional works to include grass cutting and vegetation removal;

"the works period" means the period starting on 00.01 hours on Monday 10 January 2011 and ending when the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on the trunk road.
- **4.** Subject as mentioned in articles 5 and 6 no person shall, during the works period, cause or permit any vehicle to enter the northbound carriageway of the trunk road between points 50 metres north and 70 metres south of the centre line of the overbridge at M1 Junction 13, Brogborough.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.
 - **6.** Nothing in article 4 shall apply to a vehicle
 - (a) being used for, or in connection with, the works,
 - (b) being used for winter service maintenance or traffic officer purposes,
 - (c) being used for police, fire and rescue authority or ambulance purposes, or

(d) proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for a purpose described in paragraph (c) of this article.
