ROAD TRAFFIC

The A38 Trunk Road (Hilliards Cross to Clay Mills, Staffordshire) (Slip Roads) (Temporary Prohibition of Traffic) Order 2011

Made	-	-	4th April 2011
Coming into force	-	-	11th April 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A38 Trunk Road ("the A38) and connecting roads, is satisfied that traffic on some of those connecting roads, between Hilliards Cross and Clay Mills in the County of Staffordshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order: -

1. This Order may be cited as the A38 Trunk Road (Hilliards Cross to Clay Mills, Staffordshire) (Slip Roads) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 11th April 2011.

^{2.} In this Order:

"the works period"	means the period starting at 20.00 hours on Monday 18th		
	April 2011 and ending when the said works have been		
	completed;		

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the slip road leading -

- (a) to and from the northbound carriageway of the A38 at its junction with Wood End Lane, at Hilliards Cross;
- (b) to and from the southbound carriageway of the A38 at its junction with Brookhay Lane, at Hilliards Cross;

- (c) from the northbound carriageway of the A38 to the A513 at Alrewas;
- (d) to and from the northbound carriageway of the A38 at its junction with Dogshead Lane, (Catholme Interchange);
- (e) to and from the southbound carriageway of the A38 at its junction with Catholme Lane, (Catholme Interchange); and
- (f) from the northbound carriageway of the A38 to the A5121 Derby Road (Clay Mills Interchange).

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 5. The provisions of article 3 shall not apply to any vehicle
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable; or
 - (c) being used in connection with the said works.
