ROAD TRAFFIC

The M621 Motorway (Junction 1 to Junction 7) (Temporary Prohibition of Traffic) Order 2011

 Made
 21st April 2011

 Coming into force
 30th April 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the M621 Motorway and connecting roads in the District of Leeds in the County of West Yorkshire, is satisfied that traffic on some of those connecting roads, should be prohibited because cyclic maintenance and routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) makes the following Order: -

1. This Order may be cited as the M621 Motorway (Junction 1 to Junction 7) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 30th April 2011.

2. In this Order:

"a slip road" means any of the following slip roads on the M621 Motorway:

- (i) the clockwise entry slip road at Junction 1,
- (ii) the clockwise entry slip road at Junction 2,
- (iii) the anti-clockwise exit slip road at Junction 2,
- (iv) the anti-clockwise entry slip road at Junction 2,
- (v) the clockwise entry slip road at Junction 2a,
- (vi) the anti-clockwise exit slip road at Junction 2a,
- (vii) the anti-clockwise exit slip road at Junction 3,
- (viii) the anti-clockwise exit slip road at Junction 4,
- (ix) the anti-clockwise entry slip road at Junction 4,
- (x) the clockwise entry slip road at Junction 5,
- (xi) the anti-clockwise exit slip road at Junction 5,
- (xii) the clockwise exit slip road at Junction 6,
- (xiii) the anti-clockwise entry slip road at Junction 6,
- (xiv) the clockwise exit slip road at Junction 7, or
- (xv) the anti-clockwise entry slip road at Junction 7;

"the works period" means a period of 7 hours commencing at 03:00 hours on Sunday 1st May 2011 or any subsequent Saturday or Sunday thereafter until the said works have been completed; and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in a slip road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
