## ROAD TRAFFIC

The A11 Trunk Road (A1066 Mundford Road Roundabout to A134 Brandon Road Roundabout, Thetford, Norfolk) (Temporary Prohibition of Traffic) Order 2011

 Made
 3rd May 2011

 Coming into force
 10th May 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A11 Trunk Road ("the A11") is satisfied that traffic on that trunk road in the County of Norfolk should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order: -

**1.** This Order may be cited as the A11 Trunk Road (A1066 Mundford Road Roundabout to A134 Brandon Road Roundabout, Thetford, Norfolk) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 10th May 2011.

## 2. In this Order -

"the trunk road" means the A11 from its junction with the A134/A1066 Mundford Road Roundabout to its junction with the B1107/A134 Brandon Road Roundabout, Thetford;

"lay-by" means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means a way constituting or comprised in a trunk road (other than a cycle track) over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"works" mean carriageway resurfacing and installation of road markings;

"a works period" means a period of 10 hours starting at 20.00 hours on Monday 16 May 2011 or on any subsequent day until the works have been completed;

"the works period" means the period starting at 00.01 hours on Monday 16 May 2011 and ending when the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- 3. Subject as mentioned in article 5 no person shall cause or permit any vehicle to enter -
  - (a) or proceed in the trunk road, during a works period,

- (b) the trunk road at its junction with the northbound or southbound access roads leading from Abbey Heath Service Area, during a works period, or
- (c) any lay-by adjacent to the trunk road during the works period.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.
  - **5.** Nothing in article 3 shall apply to a vehicle
    - (a) being used for, or in connection with, the works,
    - (b) being used for traffic officer purposes,
    - (c) being used for police, fire and rescue authority or ambulance purposes, or
    - (d) proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform;
