# The Air Navigation (Restriction of Flying) (Royal Air Force Waddington) Regulations 2011

 Made
 4th May 2011

 Coming into force
 28th June 2011

The Secretary of State deems it necessary in the public interest to restrict flying in the vicinity of Royal Air Force Waddington, Lincolnshire by reason of the intended holding of flying displays and associated rehearsals that are scheduled to take place on 28th June and during the period from 30th June to 3rd July 2011.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

- **1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Royal Air Force Waddington) Regulations 2011 and come into force on 28th June 2011.
- 2.—(1) Subject to paragraph (2), on the dates specified in column 1 of the Schedule and during the periods specified in column 2, no aircraft is to fly below the height specified in column 3 within the area bounded by a circle having a radius of 6 nautical miles whose centre is at 531008N 0003106W.
- (2) Paragraph (1) does not apply to any aircraft flying in accordance with a clearance issued by the air traffic control unit at Royal Air Force Waddington.
  - (3) All times referred to in the Schedule are Co-ordinated Universal Time.

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

On 28th June and during the period from 30th June to 3rd July 2011, Royal Air Force Waddington will hold "At Home Days" for the general public that will include rehearsals and flying displays. A large number of aircraft will be involved in high energy manoeuvres during these displays. The Ministry of Defence considers that Restriction of Flying Regulations should be established in the vicinity of Royal Air Force Waddington for reasons of public safety and this has been agreed with the Civil Aviation Authority's Directorate of Airspace Policy (DAP) and the Department for Transport.

Full details of the Statutory Instrument will be promulgated by Aeronautical Information Circular and NOTAM.
