The A249 Trunk Road (Bobbing Junction – Stockbury Roundabout) (Temporary Prohibition of Traffic) Order 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A249 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on a length of that road and on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act $1984(\mathbf{a})$, hereby makes the following Order:-

1. This Order may be cited as the A249 Trunk Road (Bobbing Junction – Stockbury Roundabout) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 4th June 2011.

2. In this Order:

"the trunk road" means the A249 Trunk Road in the County of Kent;

"the length of carriageway" means the southbound carriageway of the trunk road between Bobbing Junction (B2006 – Staplehurst Road) and Stockbury roundabout at M2 Junction 5;

"lay-by" means an area of carriageway, intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of the carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**);

"the A249 lay-by" means the lay-by adjacent to the southbound carriageway of the trunk road immediately northeast of Wormdale Hill overbridge northeast of Stockbury roundabout (M2 Junction 5);

"a slip road" means -

- (i) the road leading to the southbound carriageway of the trunk road at Bobbing Junction (B2006 Staplehurst Road), or
- (ii) the road leading to the southbound carriageway of the trunk road at Key Street (A2);

"works" means joint repair, catseye and white lining work on the trunk road;

"a first works period" means a period of 24 hours starting at 0001 hours on Monday 6th June 2011 or any subsequent day until 3rd December 2012; and

"a second works period" means a period of 10 hours starting at 2000 hours on Monday 6th June 2011 or on any subsequent day until 3rd December 2012.

3. Subject as mentioned in article 4 below, no person shall, during -

- (a) a first works period, cause or permit any vehicle to enter or proceed in, or wait on, the A249 lay-by; or
- (b) a second works period, cause or permit any vehicle to enter or proceed in the length of carriageway or a slip road.

4. The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
