## ROAD TRAFFIC

## The M3 Motorway (Junctions 13 and 14, Slip/Link Roads) (Temporary Prohibition of Traffic) Order 2011

 Made
 16th May 2011

 Coming into force
 5th June 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the M3 Motorway and connecting roads, is satisfied that traffic should be prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M3 Motorway (Junctions 13 and 14, Slip/Link Roads) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 5th June 2011 and shall apply for a period of twelve months.

## 2. In this Order:

"the motorway" means the M3 Motorway near Eastleigh in the County of Hampshire;

"the slip road" means the road leading to the southbound carriageway of the motorway from the A335 (Leigh Road) at Junction 13;

"the link road" means the road leading from the southbound carriageway of the motorway at Junction 13 (A335 Leigh Road) and Junction 14 to the westbound carriageway of the M27 at Junction 4:

"works" mean essential carriageway repairs and associated works on the motorway; and

"a works period" means a period of –

- (i) 7½ hours starting at 2200 hours on Monday 6th June 2011 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2230 hours on Friday 10th June 2011 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 11th June 2011 or on any subsequent Saturday, or
- (iv) 7 hours starting at 2230 hours on Sunday 5th June 2011 or on any subsequent Sunday,

until Monday 4th June 2012.

- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the slip road or the link road.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
  - (a) a vehicle being used in connection with the said works;
  - (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
  - (d) any vehicle being used for winter maintenance purposes.
