ROAD TRAFFIC

The A50 Trunk Road (Uttoxeter to Toyota Interchange) (Temporary Prohibition of Traffic) Order 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50") and connecting roads, is satisfied that traffic on lengths of that road and some of those connecting roads, between Uttoxeter and Findern in the Counties of Staffordshire and Derbyshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order: -

1. This Order may be cited as the A50 Trunk Road (Uttoxeter to Toyota Interchange) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 3rd June 2011.

2. In this Order:

"the works period"	means the period starting at 20:00 hours on Friday 10th
	June 2011 and ending when the said works have been
	completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed on -

- (a) the eastbound carriageway of the A50 from its roundabout junction with the A515 and Aston Lane at Sudbury to its junction with the slip road leading from its roundabout junction with the A511 and Packenham Boulevard;
- (b) the eastbound carriageway of the A50 from its junction with the slip road leading to its roundabout junction with the A511 and Packenham Boulevard to its junction with the slip road leading from its roundabout junction with the A516 and Willowpit Lane, at Hilton;
- (c) the slip road leading to the eastbound carriageway of the A50 from its roundabout junction with the A511 and Packenham Boulevard;

- (d) the slip road leading from the westbound carriageway of the A50 to its roundabout junction with the A522 and New Road at Uttoxeter;
- (e) the slip road leading from the westbound carriageway of the A50 to its roundabout junction with the A516 and A5132 at Hilton; and
- (f) the slip road leading to the westbound carriageway of the A50 from its roundabout junction with the A38 and B5008 (Toyota Interchange).

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

5. The provisions of article 3 shall not apply to any vehicle –

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable; or
- (c) being used in connection with the said works.
