## ROAD TRAFFIC

## The M45 Motorway (Thurlaston to M1 Junction 17) (Temporary Prohibition of Traffic) Order 2011

Made 6th June 2011 Coming into force -13th June 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the M45 Motorway ("the M45"), the M1 Motorway ("the M1") and connecting roads, is satisfied that traffic on lengths of that motorway and on three of those connecting roads in the Counties of Warwickshire and Northamptonshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the M45 Motorway (Thurlaston to M1 Junction 17) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 13th June 2011.

## 2. In this Order –

"the motorway" means the eastbound and westbound carriageways of the

M45 from its roundabout junction with the A45 Coventry Road and B4429 at Thurlaston to its junction with the M1

near Kilsby (M1 Junction 17);

"a slip road" means -

> i) the slip road leading from the eastbound carriageway of the M45 to its roundabout junction with the A45 Daventry Road and the

B4429, near Dunchurch; and

the slip road leading to the westbound ii) carriageway of the M45 from the A45 Daventry

Road, near Dunchurch;

"the link road" means the link road leading from the northbound

carriageway of the M1 at Junction 17 to the M45;

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1

"the works period"

means the period starting at 20:00 hours on Monday 20th June 2011 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the motorway, a slip road or the link road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - 5. The provisions of articles 3 shall not apply to any vehicle
    - (a) being used for police, fire brigade or ambulance purposes; or
    - (b) proceeding at the direction of, or with the permission of, a police constable, or a traffic officer in uniform; or
    - (c) being used in connection with the said works or by a traffic officer in uniform.
