**ENVIRONMENTAL PROTECTION, ENGLAND AND WALES**

**The Pollution Prevention and Control (Designation of Directives) (England and Wales) Order 2011**

*Made* - - - -

*14th June 2011*

*Coming into force* - -

*12th July 2011*

The Secretary of State, in relation to England, and the Welsh Ministers, in relation to Wales, make this Order in exercise of the powers conferred by paragraph 20(2)(c) of Schedule 1 to the Pollution Prevention and Control Act 1999(a).

**Citation, commencement, extent and application**

1.—(1) This Order may be cited as the Pollution Prevention and Control (Designation of Directives) (England and Wales) Order 2011; it extends to England and Wales and comes into force on 12th July 2011.

(2) This Order applies to the sea adjacent to England and Wales out as far as the seaward boundary of the territorial sea; and for that purpose—

- (a) the sea adjacent to England is so much of the sea adjacent to Great Britain as is not the sea adjacent to Wales or the sea adjacent to Scotland;
- (b) the sea adjacent to Wales has the same meaning as it has by virtue of section 158(3) or (4) of the Government of Wales Act 2006(b); and
- (c) the sea adjacent to Scotland has the same meaning as the internal waters and territorial sea of the United Kingdom adjacent to Scotland has by virtue of section 126(2) of the Scotland Act 1998(c).

Those functions were then transferred to the Welsh Ministers by section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006, c. 32.

## Revocation

2. The Pollution Prevention and Control (Designation of Directives) (England and Wales) Order 2010(a) is revoked.

This Order designates 22 Directives as relevant directives for the purposes of paragraph 20(2)(c) of Schedule 1 to the Pollution Prevention and Control Act 1999.

The effect of this Order is that regulations may be made under that Act making provision which corresponds or is similar to any provision made, or capable of being made, under section 2(2) of the European Communities Act 1972 in connection with any of the relevant directives.

An impact assessment has not been produced for this instrument as no impact on the public, private or voluntary sectors is foreseen.
