The M60 Motorway (Junctions 11, 13 and 16 Anticlockwise and Clockwise Exit and Entry Slip Roads) (Temporary Prohibition of Traffic) Order 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the M60 Motorway and its slip roads, is satisfied that traffic on four of those slip roads in the District of Salford in Greater Manchester should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984 (a), hereby makes the following Order:-

1. This Order may be cited as the M60 Motorway (Junctions 11, 13 and 16 Anticlockwise and Clockwise Exit and Entry Slip Roads) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 30th June 2011.

2. In this Order;

"motorway" means the M60 Motorway;

"works" means cyclical maintenance works on the motorway;

"the first works period" means periods overnight between 2200 hours and 0500 hours during the following periods:

- (i) starting on Friday 1 July 2011 and ending on Saturday 2 July 2011; and
- (ii) starting on Monday 3 October 2011 and ending on Tuesday 4 October 2011.

However, work may start and continue between the same times on subsequent nights or continue until completed, for such period not exceeding 18 months as shall be required to complete the work;

"the second works period" means periods overnight between 2200 hours and 0500 hours during the following periods:

- (i) starting on Friday 8 July 2011 and ending on Saturday 9 July 2011; and
- (ii) starting on Monday 10 October 2011 and ending on Tuesday 11 October 2011.

However, work may start and continue between the same times on subsequent nights or continue until completed, for such period not exceeding 18 months as shall be required to complete the work;

"the third works period" means periods overnight between 2200 hours and 0500 hours during the following periods:

- (i) starting on Thursday 14 July 2011 and ending on Friday 15 July 2011; and
- (ii) starting on Friday 14 October 2011 and ending on Saturday 15 October 2011.

However, work may start and continue between the same times on subsequent nights or continue until completed, for such period not exceeding 18 months as shall be required to complete the work;

"the first slip road" means the entry slip road leading to the clockwise carriageway of the motorway at Junction 13;

"the second slip road" means the entry slip road leading to the anticlockwise carriageway of the motorway at Junction 13;

"the third slip road" means the exit slip road leading from the anticlockwise carriageway of the motorway at Junction 11;

"the fourth slip road" means the entry slip road leading to the clockwise carriageway of the motorway at Junction 16;

- **3.** Subject as mentioned in article 6 of this Order, during the first works period, no person shall cause or permit any vehicle to enter or proceed in the first or second slip roads.
- 4. Subject as mentioned in article 6 of this Order, during the second works period, no person shall cause or permit any vehicle to enter or proceed in the third slip road.
- 5. Subject as mentioned in article 6 of this Order, during the third works period, no person shall cause or permit any vehicle to enter or proceed in the fourth slip road.
- 6. The provisions of articles 3, 4 and 5 of this Order shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle being used for emergency purposes by the police, fire and rescue or ambulance services, vehicles being used in connection with the works, or by traffic officers, or any vehicle proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform.
