**ROAD TRAFFIC**

**The M11 Motorway (Junction 14) and the A14 Trunk Road  
(Junction 29 Bar Hill Interchange to Junction 32 Histon  
Interchange, Cambridgeshire) (Temporary Restriction and  
Prohibition of Traffic) Order 2011**

*Made* - - - - 20th June 2011  
*Coming into force* - - 27th June 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the M11 Motorway (“the M11”), the A14 Trunk Road (“the A14”) and connecting roads, is satisfied that traffic on lengths of that motorway and that road, and on some of those connecting roads, in the County of Cambridgeshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the M11 Motorway (Junction 14) and the A14 Trunk Road (Junction 29 Bar Hill Interchange to Junction 32 Histon Interchange, Cambridgeshire) (Temporary Restriction and Prohibition of Traffic) Order 2011 and shall come into force on 27th June 2011.

2. In this Order –

“the A1307” means the length of A1307 between its junction with Cambridge University Farm up to, and including, Girton Interchange;

“Girton Interchange” means the M11 (Junction 14)/A14 (Junction 31)/A428 Interchange at Girton Cambridgeshire;

“the eastbound Clover Leaf” means the A14 eastbound link road leading from the A14/M11 north-westbound carriageway to the A428/A14 eastbound carriageway, known locally as the eastbound Clover Leaf link road;

“the westbound Clover Leaf” means the A14 westbound link road leading from the A14 westbound carriageway to the A14 north-westbound carriageway, known locally as the westbound Clover Leaf link road;

“Crematorium Loop” means the length of road linking the A14 eastbound carriageway and the A14 westbound carriageway, known locally as the Crematorium Loop;

“tip of the nosing” means, as indicated by the road markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the motorway or the trunk road;

“Schedule” means the Schedule to this Order;

“works” mean a road lighting technical survey and the renewal of road lighting and investigation work on the M11 and A14 at Girton Interchange, resurfacing/patch repairs, lining refurbishment, stud replacement, lighting repairs/electrical works, safety vario-guard safety fencing repairs, barrier painting, grass cutting, litter picking, sweeping, gully emptying, drainage jetting, weed spraying, bridge inspections, communications maintenance, sign repair/maintenance, tree maintenance, visual carriageway inspection and slope failure surveys;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number and a reference to a bridge is a reference to the centre point of that bridge.

**3.** Subject as mentioned in articles 5, 6 and 7 no person shall drive any vehicle at a speed exceeding 50 miles per hour on a length of motorway or trunk road specified in Part I of the Schedule column (1), during a period specified in column (2).

**4.** Subject as mentioned in articles 5 and 6 no person shall cause or permit any vehicle to enter or proceed in a length of motorway, a length of trunk road, a link road, a slip road or a lay-by specified in Part II of the Schedule column (1), during a period specified in column (2).

**5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.

**6.** Nothing in article 4 shall apply to a vehicle –

- (a) being used for, or in connection with, the works or for traffic officer purposes,
- (b) being used for police, fire and rescue authority or ambulance purposes, or
- (c) proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform,

and nothing in article 3 shall apply to a vehicle being used for a purpose specified in paragraph (b) of this article.

**7.** The provisions of article 3 shall not apply to a vehicle falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

**8.** The provisions of Regulations 5 and (insofar as it relates to a vehicle being driven 9) of the Motorways Traffic (England and Wales) Regulations 1982(b) are suspended in relation to the hard shoulder adjacent to the length of carriageway described in the Schedule, Part II Paragraph 4(a), at such times and to such extents as may be indicated by traffic signs; and in this article “hard shoulder” has the meaning given in regulation 3(1)(e) of those Regulations.
