## ROAD TRAFFIC

The A419 Trunk Road (Castle Eaton, Kingshill and Lower Widhill Farm Junctions, Near Cricklade, Wiltshire) (Temporary Prohibition of Traffic) Order 2011

 Made
 12th July 2011

 Coming into force
 15th July 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A419 Trunk Road ("the A419"), is satisfied that traffic on a length of that road near Cricklade in Wiltshire should be prohibited because of the likelihood of danger to the public during the Royal International Air Tattoo:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(b) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A419 Trunk Road (Castle Eaton, Kingshill and Lower Widhill Farm Junctions, Near Cricklade, Wiltshire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 15th July 2011.

## 2. In this Order –

"the A419" means the A419 between the Cricklade Junction and the Lady Lane Junction, near Swindon:

"the period of danger" means the period starting at 00.01 hours on Saturday 16th July 2011 and ending at 23.59 hours on Sunday 17th July 2011;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the period of danger, cause or permit any vehicle:
  - (a) proceeding northwestwards on the A419 to turn right into the C114 towards Castle Eaton;
  - (b) on entering the A419 from the C114 to proceed in any direction other than leftwards;
  - (c) proceeding southeastwards on the A419 to turn right into Kingshill Farm;
  - (d) on entering the A419 from Kingshill Farm to proceed in any direction other than leftwards;
  - (e) proceeding southeastwards on the A419 to turn right into Lower Widhill Farm;
  - (f) on entering the A419 from Lower Widhill Farm to proceed in any direction other than leftwards.
