## ROAD TRAFFIC

## The M25 Motorway (Junction 27, Clockwise) (Temporary Prohibition of Traffic) Order 2011

Made - - - - 8th August 2011

Coming into force - - 30th August 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the M25 Motorway and connecting roads, is satisfied that traffic should be prohibited on a length of that motorway and on one of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the M25 Motorway (Junction 27, Clockwise) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 30th August 2011.

## 2. In this Order:

"the motorway" means the M25 Motorway in the County of Essex;

"the length of carriageway" means the clockwise carriageway of the motorway between the link road leading to both carriageways of the M11 and the link road leading from the southbound carriageway of the M11 at Junction 27 (M11 Junction 6);

"the link road" means the road leading to the clockwise carriageway of the motorway from the northbound carriageway of the M11 at Junction 27;

"works" means resurfacing, expansion joint repair, white lining and road stud works on the motorway; and

"a works period" means a period of -

- (i) 7½ hours starting at 2200 hours on Thursday 1st September 2011 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2300 hours on Friday 2nd September 2011 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 3rd September 2011 or on any subsequent Saturday, or
- (iv) 7 hours starting at 2230 hours on Sunday 4th September 2011 or on any subsequent Sunday,

until 28th February 2013.

**3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the length of carriageway or the link road.

- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
  - (a) a vehicle being used in connection with the said works;
  - (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
  - (d) any vehicle being used for winter maintenance purposes.
