## ROAD TRAFFIC

The A43 Trunk Road (Silverstone, Northamptonshire) (Temporary 50 Miles Per Hour Speed Restriction) (No.2) Order 2011

 Made
 8th August 2011

 Coming into force
 15th August 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A43 Trunk Road ("the A43") and connecting roads, is satisfied that traffic on lengths of that road and some of those connecting roads near Silverstone in the County of Northamptonshire should be restricted because of the likelihood of danger to the public:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(b) of the Road Traffic Regulation Act 1984 (a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

- **1.** This Order may be cited as the A43 Trunk Road (Silverstone, Northamptonshire) (Temporary 50 Miles Per Hour Speed Restriction) (No.2) Order 2011 and shall come into force on 15th August 2011.
- **2.** Subject as mentioned in article 3 of this order, no person shall, during the period starting at 00.01 hours on Saturday 20th August 2011 and ending when the said likelihood of danger has been avoided by means other than this order, drive any motor vehicle at a speed exceeding 50 miles per hour on
  - (a) the northbound carriageway of the A43 from a point 1130 metres south of its junction with the slip road leading to the A413 to a point 390 metres north of the centreline of Dadford Road overbridge;
  - (b)the northbound carriageway of the A43 between a point 1000 metres south and a point 560 metres north of the centre line of the A413 Whittlewood overbridge;
  - (c) the southbound carriageway of the A43 between a point 1200 metres north and a point 100 metres south of its junction with the slip road leading to the A413;
  - (d) the southbound carriageway of the A43 from a point 625 metres north of the centreline of Winterhills Road overbridge for a distance of 4010 metres in a southerly direction;

- (e) the slip road leading from the northbound carriageway of the A43 to the A413;
- (f) the slip road leading to the northbound carriageway of the A43 from Dadford Road;
- (g) the slip road leading to the northbound carriageway of the A43 from the A413;
- (h)the slip road leading from the southbound carriageway of the A43 to the A413;
- (i) the slip road leading from the southbound carriageway of the A43 to Dadford Road; and
- (j) the slip road leading to the southbound carriageway of the A43 from Dadford Road.
- **3.** The provisions of article 3 of this order shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to any vehicle
  - (a) being used for Special Forces, police, fire brigade or ambulance purposes; or
  - (b) proceeding at the direction of, or with the permission of, a police constable.
