## ROAD TRAFFIC

## The A414 Trunk Road (M1 Motorway Junction 8 to A5183/A405 Park Street Roundabout St Albans, Hertfordshire) (Temporary Prohibition of Traffic) Order 2011

 Made
 23rd August 2011

 Coming into force
 30th August 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A414 Trunk Road ("the A414"), is satisfied that traffic on lengths of that road in the County of Hertfordshire should be prohibited because works are proposed to be executed thereon:

NOW THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

**1.** This Order may be cited as the A414 Trunk Road (M1 Motorway Junction 8 to A5183/A405 Park Street Roundabout St Albans, Hertfordshire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 30th August 2011.

## 2. In this Order -

"the trunk road" means the A414 –

- (a) eastbound carriageway from a point 4960 metres west of its junction, to its junction, with the A405/A5183 Park Street Roundabout, St Albans, and
- (b) westbound carriageway from its junction with the A405/A5183 Park Street Roundabout, St Albans, westwards for a distance of 4840 metres;
- "works" mean carriageway crack and joint repairs;
- "a works period" means a period of –
- (a) 9 hours starting at 21.00 hours on Monday 5th September 2011 or on any subsequent day (other than a Saturday or a Sunday), or
- (b) 10 hours starting at 20.00 hours on Saturday 10th September 2011 or on any subsequent Saturday or Sunday,

until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that.

**3.** Subject as mentioned in articles 4 and 5 no person shall, during a works period, cause or permit any vehicle to enter or proceed in the trunk road.

- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.
  - **5.** The provisions of article 3 shall not apply to a vehicle
    - (a) being used in connection with the works or for traffic officer purposes,
    - (b) being used for police, fire and rescue authority or ambulance purposes, or
    - (c) proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform.
