## ROAD TRAFFIC

The A46 Trunk Road (Carholme Roundabout to Doddington Roundabout, Lincolnshire) (Temporary Prohibition of Traffic)
Order 2011

Made - - - - 30th August 2011

Coming into force - - - 6th September 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A46 Trunk Road ("the A46"), is satisfied that traffic on lengths of that road in the County of Lincolnshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984 (a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

**1.** This Order may be cited as the A46 Trunk Road (Carholme Roundabout to Doddington Roundabout, Lincolnshire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 6th September 2011.

## **2.** In this Order:

"Carholme Roundabout" means the A46/A57 roundabout junction near Lincoln;

"Skellingthorpe Roundabout" means the A46/B1378/Lincoln Road roundabout junction,

near Skellingthorpe;

"Doddington Roundabout" means the A46/B1190 roundabout junction;

"the trunk road" means the A46 from its junction with Carholme

roundabout to its junction with Doddington roundabout, including the circulatory carriageway of Skellingthorpe

roundabout;

"layby"

means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002 (a) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

"the works period"

means the period starting at 20.00 hours on Monday 12th September 2011 and ending when the said works have been completed,

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road.
- **4.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the layby adjacent to
  - (a) the southbound carriageway of the A46 approximately
    - (i) 1500 metres south of Carholme Roundabout; and
    - (ii) 900 metres south of Skellingthorpe Roundabout; and
  - (b) the northbound carriageway of the A46 approximately 1600 metres north of Doddington Roundabout.
  - **5**. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or leave Skellingthorpe Roundabout at its junction with the access road leading to Decoy Farm.
  - **6**. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - 7. The provisions of articles 3, 4 and 5 shall not apply to any vehicle-
    - (i) being used for police, fire brigade or ambulance purposes,
    - (ii) proceeding at the direction of, or with the permission of, a police constable, or
    - (iii) being used in connection with the said works;

and article 3 shall not apply to any vehicle proceeding in the trunk road to or from premises which are accessible for that vehicle from, and only from, that road.
