ROAD TRAFFIC

The A1(M) Motorway (Junction 58 to Junction 57) (Temporary Restriction and Prohibition of Traffic) Order 2011

Made - - - - 8th September 2011

Coming into force - - 18th September 2011

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway and connecting roads, in the Districts of Darlington and Richmondshire in the Counties of Durham and North Yorkshire, is satisfied that traffic on that motorway and one of those connecting roads should be restricted and prohibited because carriageway lining works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and (7) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the A1(M) Motorway (Junction 58 to Junction 57) (Temporary Restriction and Prohibition of Traffic) Order 2011 and shall come into force on 18th September 2011.
 - 2. In this Order; -

"the A1(M)" means the A1(M) Motorway;

"the first length of carriageway" means the A1(M) southbound carriageway from a point 1000 metres north of the centreline of Burtree Lane underbridge southwards for a distance of 4350 metres;

"the second length of carriageway" means the A1(M) southbound carriageway from the nose of the southbound exit slip road at Junction 58 (Burtree) to the nose of the southbound entry slip road at Junction 57 (Blackwell Spur), a distance of 7420 metres;

"the slip road" means the A1(M) southbound entry slip road at Junction 58;

"the works period" means a period of 10 hours starting at 20:00 hours on Monday 19th September 2011 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding:
 - (i) 50 miles per hour in the first length of carriageway or the slip road; or
 - (ii) 40 miles per hour in the first length of carriageway.
- **4.** Subject as mentioned in articles 5 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the second length of carriageway or the slip road.

- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs. Nothing in article 4 shall apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission of, a police officer or traffic officer in uniform;

and nothing in article 3 shall apply to any vehicle being used for a purpose specified in paragraph (a) of this article.

- **6.** No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**a**) when used in accordance with regulation 3(5) of those Regulations.
- **7.** The provisions of regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Motorways Traffic (England and Wales) Regulations 1982(**b**) are suspended in relation to the hard shoulder adjacent to the first length of carriageway or the slip road as described in article 2 at such times and to such extent as may, from time to time, be indicated by traffic signs; and in this article "hard shoulder" has the meaning given in regulation 3(1)(e) of those Regulations.
