## **ROAD TRAFFIC**

## The A428 Trunk Road (Tithe Farm Roundabout to Caxton Gibbet Roundabout, Cambridgeshire) (Temporary Prohibition of Traffic) Order 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A428 Trunk Road ("the A428"), is satisfied that traffic on a length of that road in the County of Cambridgeshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

**1.** This Order may be cited as the A428 Trunk Road (Tithe Farm Roundabout to Caxton Gibbet Roundabout, Cambridgeshire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 26th September 2011.

2. In this Order –

"the trunk road" means the A428 between its junctions with the B1428 Tithe Farm Roundabout and the A1198 Caxton Gibbet Roundabout;

"lay-by" means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means a way constituting or comprised in a trunk road (other than a cycle track) over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"works" mean carriageway resurfacing and road markings at Eltisley Junction and street lighting repairs and drainage maintenance;

"the works period" means the period starting at 08.00 hours on Sunday 2nd October 2011 and ending when the works have been completed;

"a works period" means a period of 10 hours starting at 20.00 hours on Monday 3rd October 2011 or on any subsequent day until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 4 and 5 no person shall cause or permit any vehicle to enter or proceed in -

- (a) the trunk road, during a works period, or
- (b) any lay-by adjacent to the trunk road, during the works period.

**4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.

5. The provisions of article 3 shall not apply to a vehicle –

- (a) being used for, or in connection with, the works, winter service maintenance or for traffic officer purposes,
- (b) being used for police, fire and rescue authority, or ambulance purposes,
- (c) proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform, or
- (d) requiring access to properties which are accessible from, and only from, the trunk road.
