ROAD TRAFFIC

The M11 Motorway (Junction 8 to Junction 10, Essex and Cambridgeshire) (Temporary Prohibition of Traffic) Order 2011

Made - - - - 3rd October 2011

Coming into force - - 10th October 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the M11 Motorway ("the M11") and connecting roads, is satisfied that traffic on lengths of that motorway and on some of those connecting roads in the Counties of Essex and Cambridgeshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order:-

1. This Order may be cited as the M11 Motorway (Junction 8 to Junction 10, Essex and Cambridgeshire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 10th October 2011.

2. In this Order -

"tip of the nosing" means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the motorway;

"the motorway" mean the M11-

- (a) northbound carriageway between the tips of the nosing's of the exit slip road at Junction 8 and the entry slip road at Junction 10,
- (b) southbound carriageway between the tips of the nosing's of the exit slip road at Junction 10 and the entry slip road at Junction 8, and
- (c) southbound carriageway between the tips of the nosing's of the entry slip road at Junction 9a and the entry slip road at Junction 8;

"a slip road" means the M11 –

- (a) northbound entry slip road at Junction 8, and
- (b) southbound entry slip roads at Junctions 9a and 10;

"works" mean carriageway resurfacing;

"a works period" means a period of -

- (a) 9 hours starting at 21.00 hours on Friday 14th October 2011 or on any subsequent Friday, or
- (b) 11 hours starting at 21:00 hours on Saturday 15th October 2011 or on any subsequent Saturday,

until the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4 no person shall, during a works period, cause or permit any vehicle to enter or proceed in the motorway or a slip road.
- **4.** The provisions of article 3 shall apply only at such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to a vehicle
 - (a) being used for, or in connection with, the works or for traffic officer purposes,
 - (b) being used for police, fire and rescue authority or ambulance purposes, or
 - (c) proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform.
