ROAD TRAFFIC

The A50 Trunk Road (South West of Derby) (Temporary Prohibition of Traffic in Laybys) Order 2011

Made 24th October 2011 Coming into force - -31st October 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road ("the A50"), is satisfied that traffic on lengths of that road, south west of the City of Derby, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A50 Trunk Road (South West of Derby) (Temporary Prohibition of Traffic in Laybys) Order 2011 and shall come into force on 31st October 2011.

2. In this Order –

"layby"

means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

"the works period"

means the period starting at 08.00 hours on Monday 7th November 2011 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3**. Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the layby situated –
- i) on the eastbound carriageway of the A50 -
 - (a) 700 metres east of the A515 roundabout (Sudbury roundabout);
 - (b) 1650 metres east of the A50/A38/B5008 interchange (Toyota interchange);
 - (c) 100 metres east of Arleston Lane overbridge; and
- ii) on the westbound carriageway of the A50
 - (a) 600 metres west of the A511 interchange overbridge;
 - (b) 350 metres west of Lowes Lane overbridge.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
- 5. The provisions of article 3 shall not apply to any vehicle -
 - (i) being used for police, fire brigade or ambulance purposes;
 - (ii) proceeding at the direction of, or with the permission of, a police constable; or
 - (iii) being used for or in connection with the said works.
