## **ROAD TRAFFIC**

## The A46 Trunk Road and the M6 and M69 Motorways (M6 Junction 2, Warwickshire) (Temporary Prohibition of Traffic) Order 2011

Made---25th November 2011Coming into force-2nd December 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the M6 Motorway ("the M6"), the M69 Motorway ("the M69"), the A46 Trunk Road ("the A46") and connecting roads, is satisfied that traffic on lengths of those motorways, that trunk road and some of those connecting roads near Ansty in the County of Warwickshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1) (a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf hereby makes the following Order:-

**1.** This Order may be cited as the A46 Trunk Road and the M6 and M69 Motorways (M6 Junction 2, Warwickshire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 2nd December 2011.

**2.** In this Order:

"the motorway" means i) the southbound carriageway of the M69 from a point 1300 metres north of the centreline of the B4065 Hinckley Road overbridge to its junction with the A46: and ii) the southbound carriageway of the M69 from its junction with exit slip road at Junction 1 to its junction with the A46; "the trunk road" means the northbound carriageway of the A46 from a point 700 metres south of its junction with the exit slip road leading to the A4600 Hinckley Road to its junction with the M69;

"the link road"	means the link leading from the southbound carriageway of the M69 to the northbound carriageway of the M6 at Junction 2;
"the works period"	means the period starting at 22:00 hours on Monday 5th December 2011 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the motorway, the trunk road, or the link road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -

- (i) being used for police, fire brigade or ambulance purposes;
- (ii) proceeding at the direction of, or with the permission of, a police constable, or a traffic officer in uniform; or
- (iii) being used in connection with the said works or by a traffic officer in uniform.
