## ROAD TRAFFIC

The A500 Trunk Road (Hanford, Stoke-on-Trent, Staffordshire) (Temporary Prohibition of Traffic in Layby) (No.2) Order 2011

Made - - - - 14th November 2011

Coming into force - - 21st November 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A500 Trunk Road ("the A500"), is satisfied that traffic on a length of that road at Hanford in the County of Staffordshire should be prohibited because of the likelihood of danger to the public:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(b) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A500 Trunk Road (Hanford, Stoke-on-Trent, Staffordshire) (Temporary Prohibition of Traffic in Layby) (No.2) Order 2011 and shall come into force on 21st November 2011.

## 2. In this Order:

"layby"

means an area of carriageway intended for the waiting of vehicles and bounded partly by a traffic sign of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that carriageway on the same side of the road as that on which the sign is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in articles 4 and 5, no person shall, during the period starting at 06.00 hours on Friday 25th November 2011 and ending when the said likelihood of danger has been avoided by means other than this Order, cause or permit any vehicle to enter or proceed in the

layby situated adjacent to the southbound carriageway of the A500 between points 533 metres and 76 metres east of the centre point of its roundabout junction with the A519 and M6 Junction 15.

- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle-
  - (i) being used for police, fire brigade or ambulance purposes; or
  - (ii) proceeding at the direction of, or with the permission of, a police constable.
